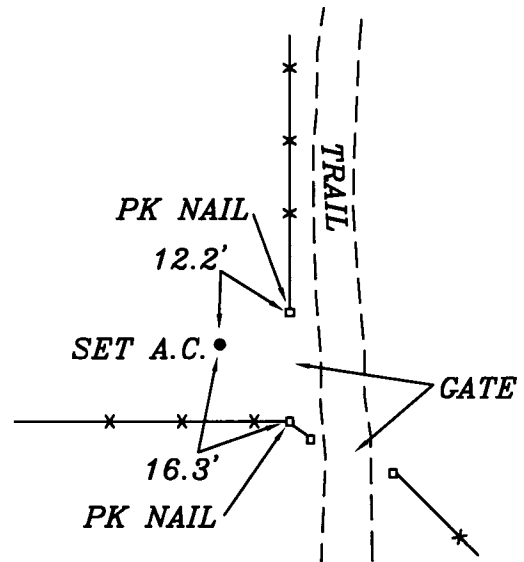
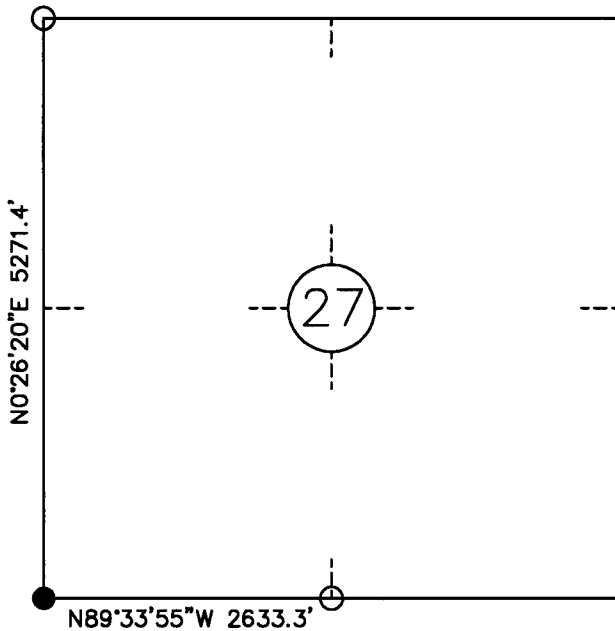

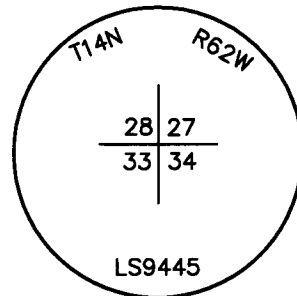
## Monument Sketch

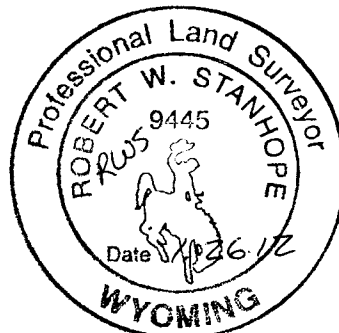
