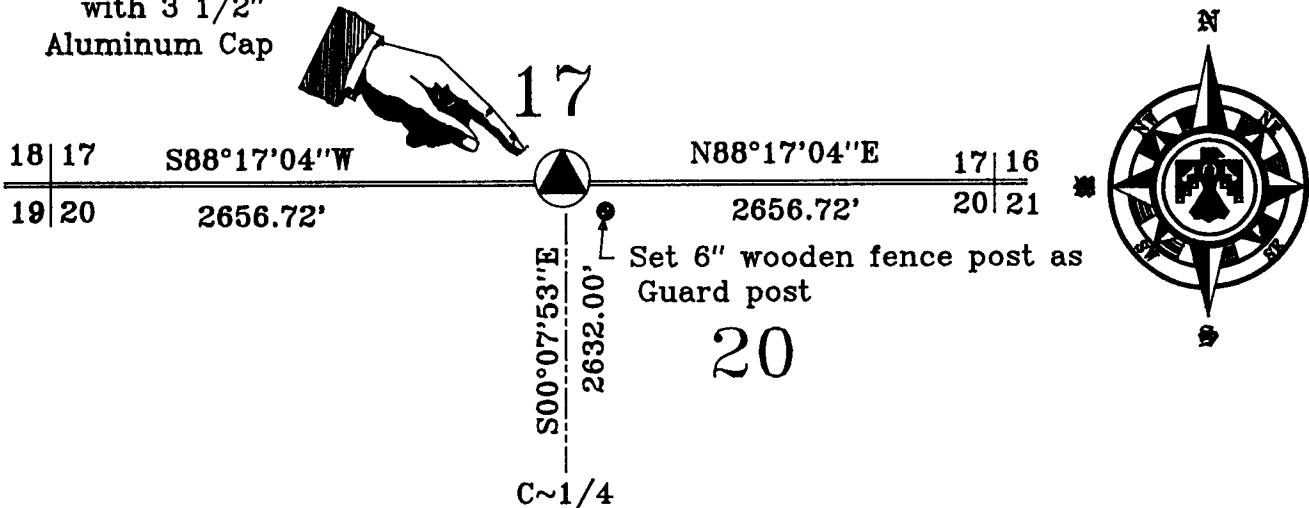

"East on a Random line between Sections 17 & 20, [Variation 15.35'E] Measure 40.00 chains set Temporary 1/4 corner; 80.65 chains, intersect N~S line 16 links S of the corner to sections 16,17,20 & 21 from which corner I run S89°53'W on a true line between Sections 17 & 20 a distance of 40.32 1/2 chains and set a sandstone 16"X12"X5" for 1/4 corner,"

Set 2"X32" iron pipe with 3" Aluminum Cap equidistant from the corner common to 17,18,19 & 20 and the corner common to Section 16,17,20 & 21.
