


State of Wyoming Corner Record


U.S.G.L.O. 1871 Record: Set a granite boulder 20x12x6 for corner to sections 13, 14, 23 & 24.

Set mag nail w/1-1/2" aluminum washer inscribed "DRG inc - LS 6098" in power pole.


CR 212 (gravel surface)

Wire 1-1/2" aluminum washer inscribed "DRG inc - LS 6098" on metal post for Yield sign.


