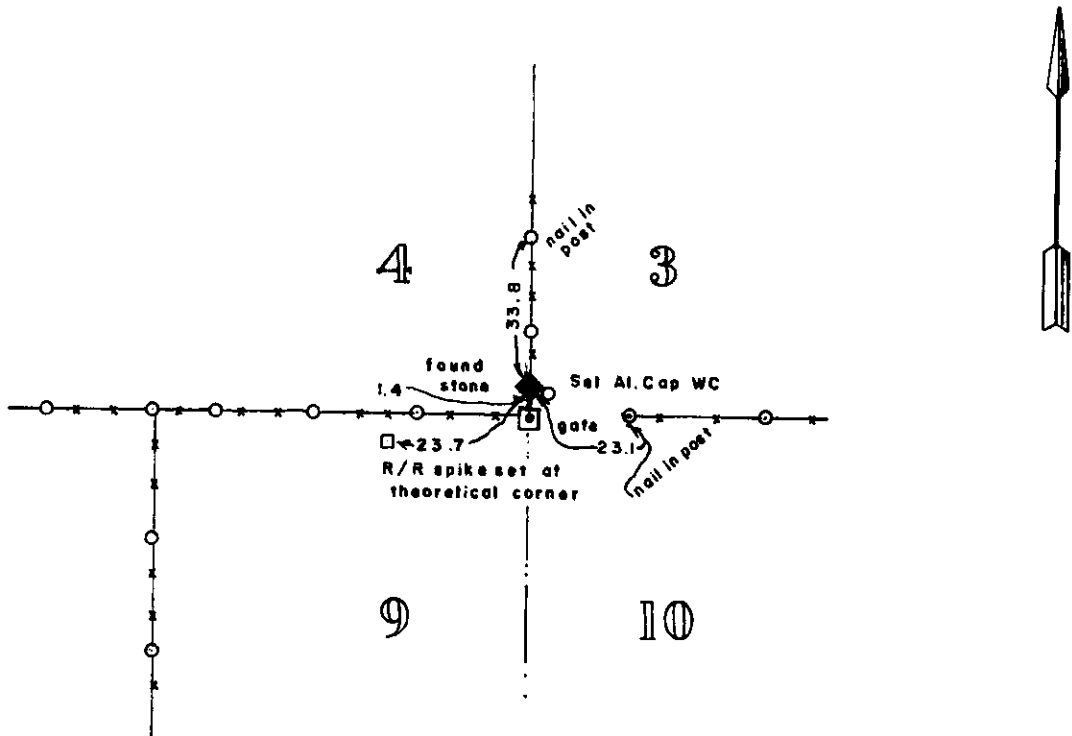

GLO North between Sec. 9 and Sec. 10 - 62 chains to old Wagon Road run East & West - 80 chains set Granite Boulder 18"x10"x7" for corner of Sec. 3,4,9 & 10).

Found granite boulder 18"x10"x7" in fence corner as shorn hereon 5 well defined hash marks on the South and 3 well defined hash marks on the East. Said corner may have been disturbed but upon double proportioning in a point as per GLO instructions, said stone appears to be reasonably close to the original location and I could not dispute said location with any certainty. Set rebar and Al. cap as W. C.
