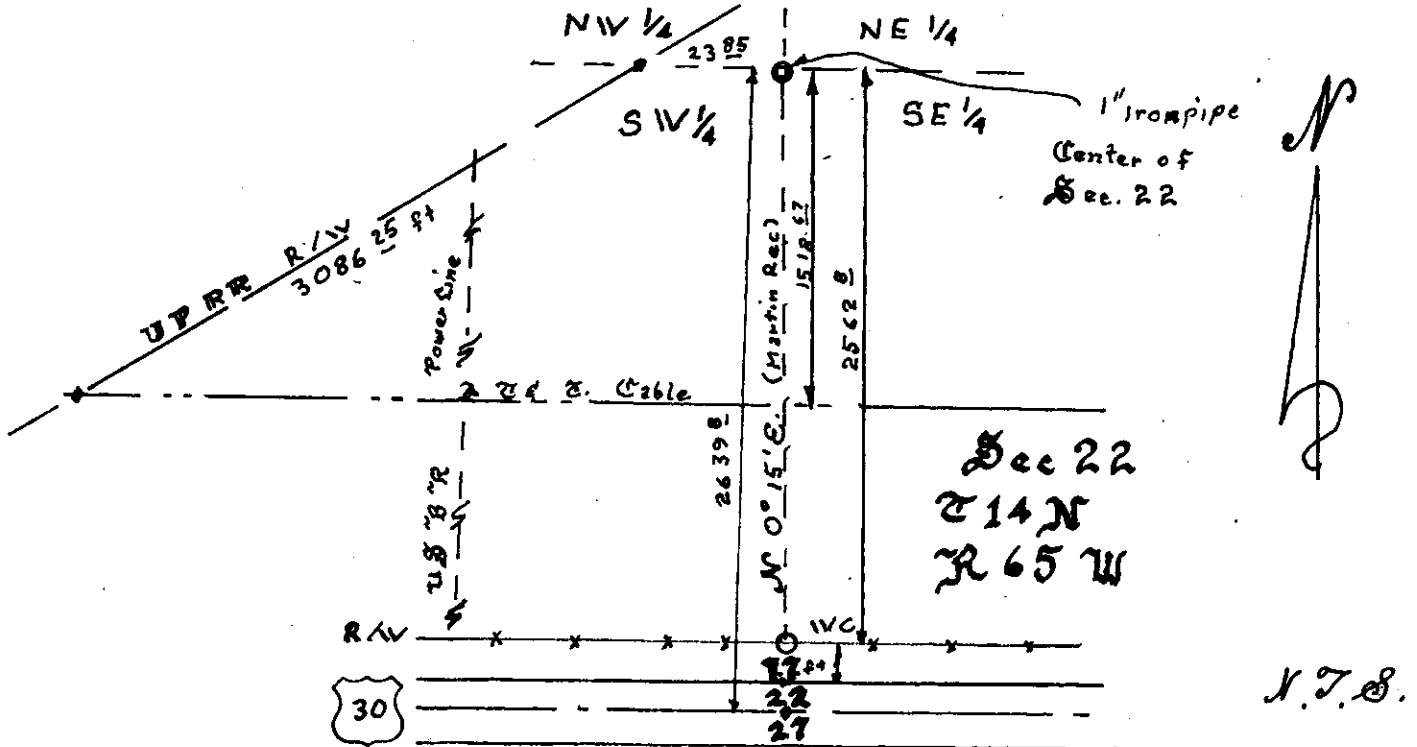
DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (if known)

Center of Section was not set by G.L.O.. Found Center of Section 22 as set and described by Malcom D. Martin L.S. 228 in book XLV, page 54 of the T.H. Baldwin records as donated to Laramie County by Mrs. E.P.Kelly. The Center of Section 22 is a 1" dia. iron pipe situate 23.85 ft. easterly from the southerly R/W of the U.P.R.R. on a line from 1/4 21 22 to 1/4 22 23, said point of intersection of the U.P.R.R. R/W and the aforementioned line is 3086.25 ft. from the crossing of the A.T.& T. cable crossing of the R/W.

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

Set #6 bebar 54" in length beside 1" dia. iron pipe found. Rebar extends approx. 2 1/2 ft above the ground elevation and is painted blue. Also set a 2 1/2 x 2 1/2 x 1/8 angle iron 7 ft in length adjacent to rebar and pipe with approx. 4 1/2 ft above the ground elevation. Said angle iron is painted blue with white horizontal stripes and is marked thusly: CENTER SECTION 22 T14N R65W on all sides of Angle iron.
