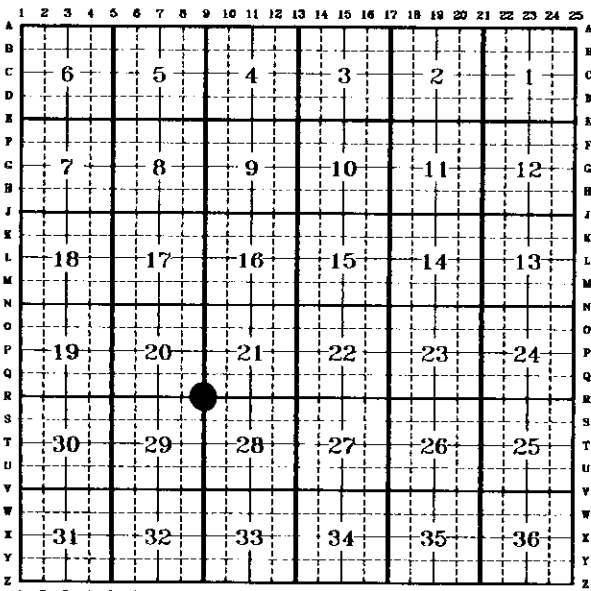

**CROSS INDEX DIAGRAM**

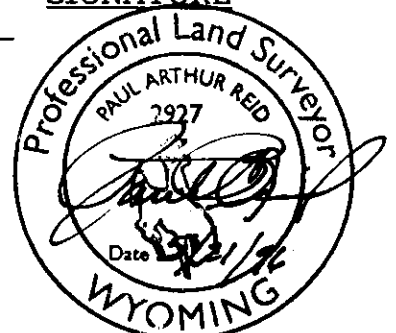
