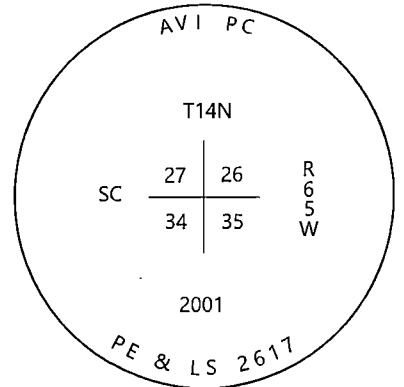
LOCATION: Northeast Corner of Section 34, T14N, R65W, 6th Principal Meridian, Laramie County.

RECORD: GLO - Set sandstone 22" X 10" X 6"

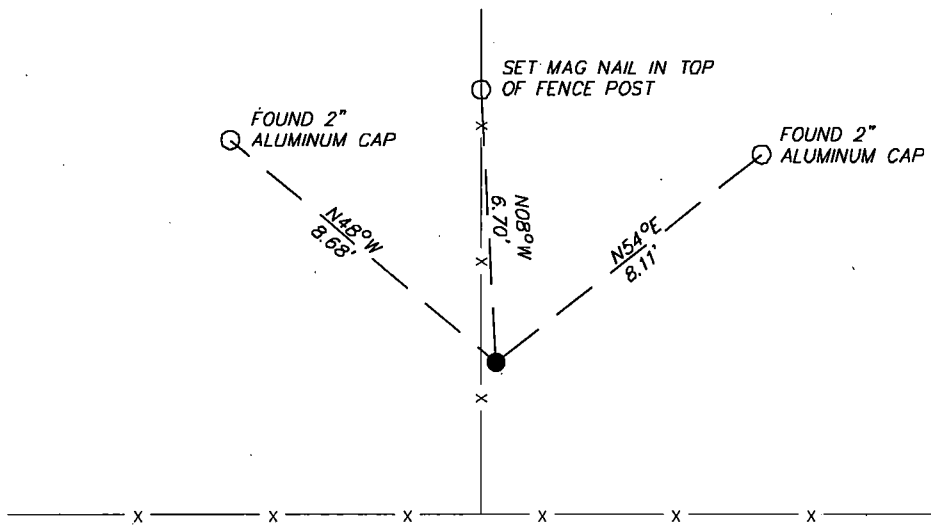
2001 - James D. Voeller found a 21" X 10" X 5" sandstone with 1 mark on the south and 2 marks on the east. He set a 3.25" aluminum cap on a 2.5" x 30" aluminum pipe stamped with LS 2617. Notes the distance to the NQ 34-T14N-R65W is 2627.26', the distance to the NQ 35-T14N-R65W is 2635.84', and the distance to the EQ 34-T14N-R65W is 2634.12'.

RECOVERED: 2019 - Westwood Professional Services found a 3.25" aluminum cap stamped LS 2617 as mentioned in the 2001 survey and 2 ties.

RESET: Accepting location of the monument as the corner location. Set an additional tie as shown.

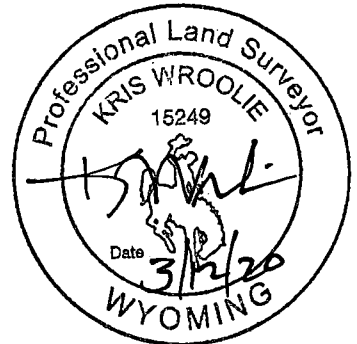
