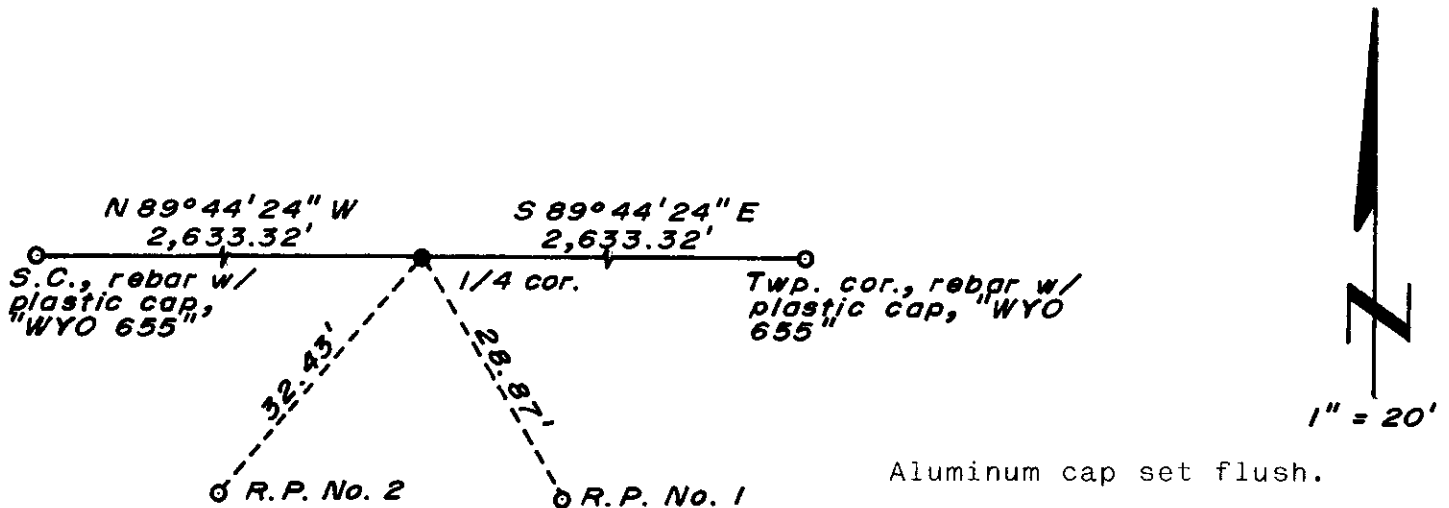
At the corner: Set a 5/8" dia. x 24" long rebar with 2" dia. aluminum cap.

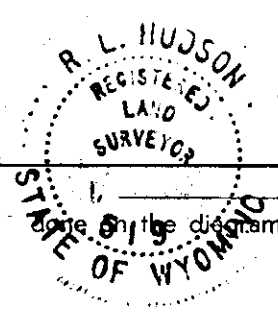
A 5/8" dia. x 24" long rebar with 1½" dia. aluminum cap bears S 40°52'30" W, 32.43 feet distant. (Stamped R.P. NO. 2)
