DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (If known)

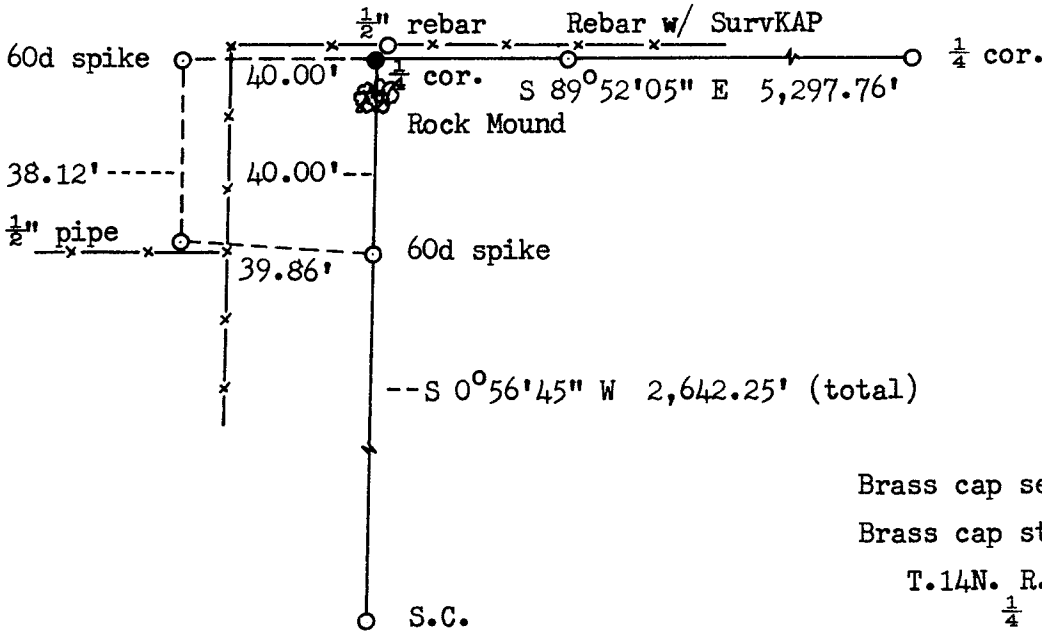

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set a  $\frac{1}{2}$ " dia. x 30" long iron pipe with brass cap.  
 Accessories: Raised a rock mound, 2 feet S of corner monument.  
 A  $\frac{1}{2}$ " dia. iron pipe (found) bears S 47°13'45" W, 55.14 feet distant.
