Found: 1 1/2" aluminum cap marked "BRW NOBLITT LS 2500", 174.03' east of 1/4 corner position and as per Cheyenne Airport Addition Subdivision Plat. The p.k nail as noted in the Certified Corner Record filed Jan. 7, 1982, was not existing due to concrete replacement and obliterated at the time of this survey.

Set: 2 1/2" aluminum cap marked as noted below, 0.03' below concreted Air National Guard aircraft parking area. Aluminum cap was set and anchored in the concrete with anchoring cement and 3 mag p.k nails in the bottom of the drilled hole for detection with a Schonstedt magnetic locator.

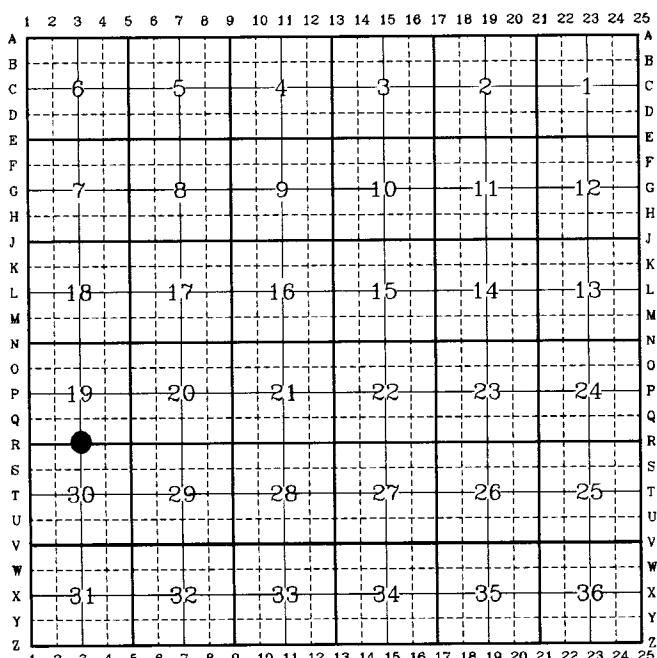

CROSS INDEX DIAGRAM

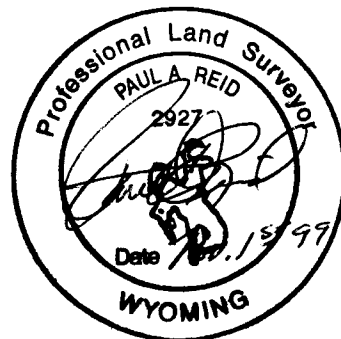
