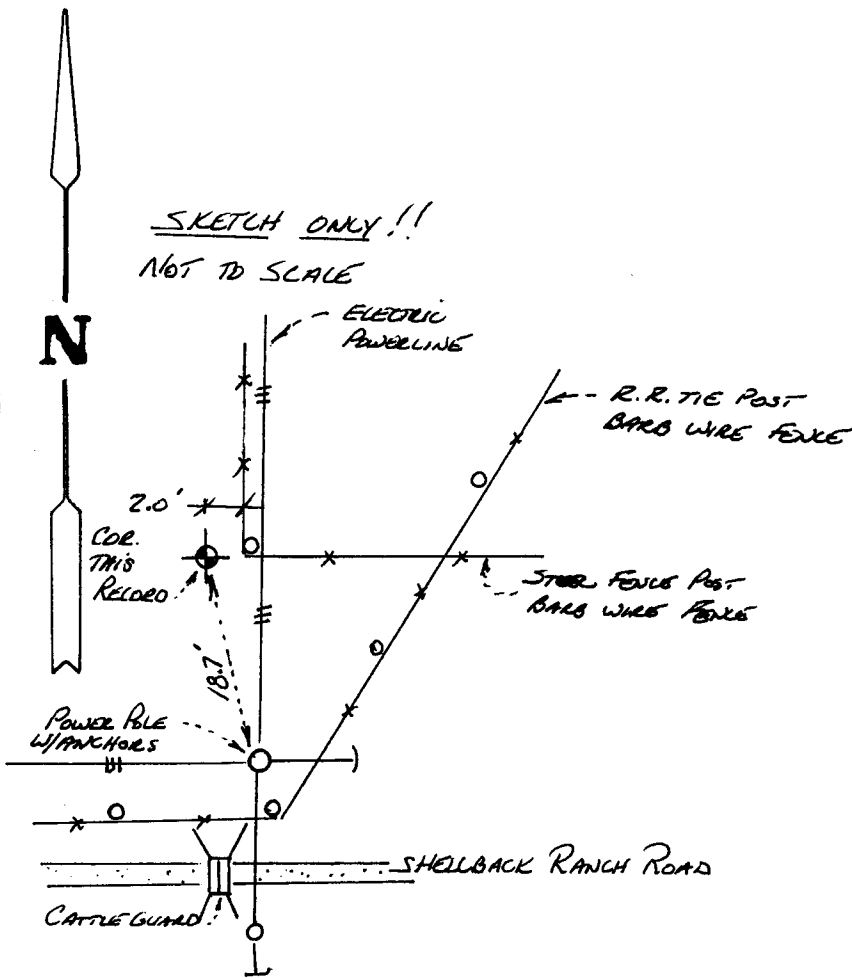
Set: 2 1/2" x 30" Galvanized Iron Pipe, 26" in the ground with a 3 1/4" Brass Cap marked as noted below. Buried the original stone as a memorial south of the remonumented corner point. Set the L.T. Perry 6' blue fence post 1' north and 3 feet in the ground as a witness.

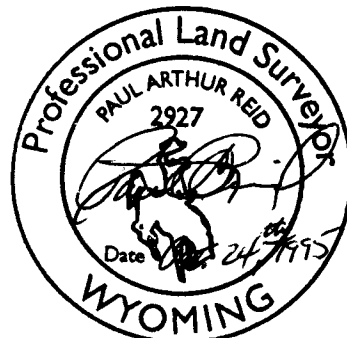
