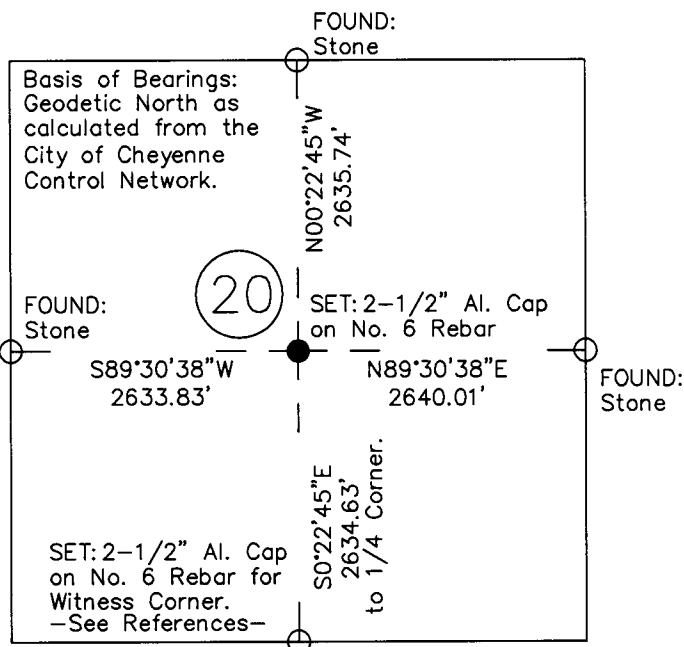

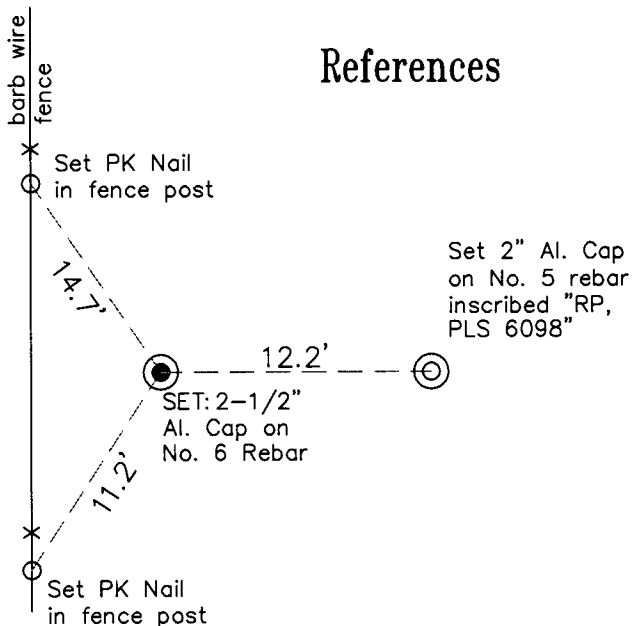
Calculated the corner position at the intersection of the E-W center section line with the N-S center section line.

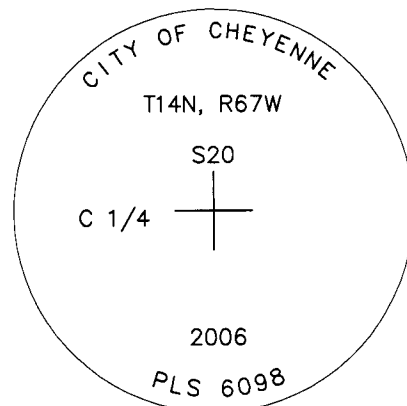
Monument location

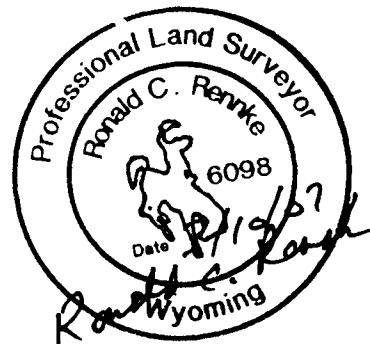
