

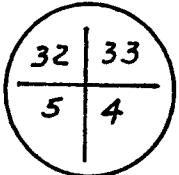

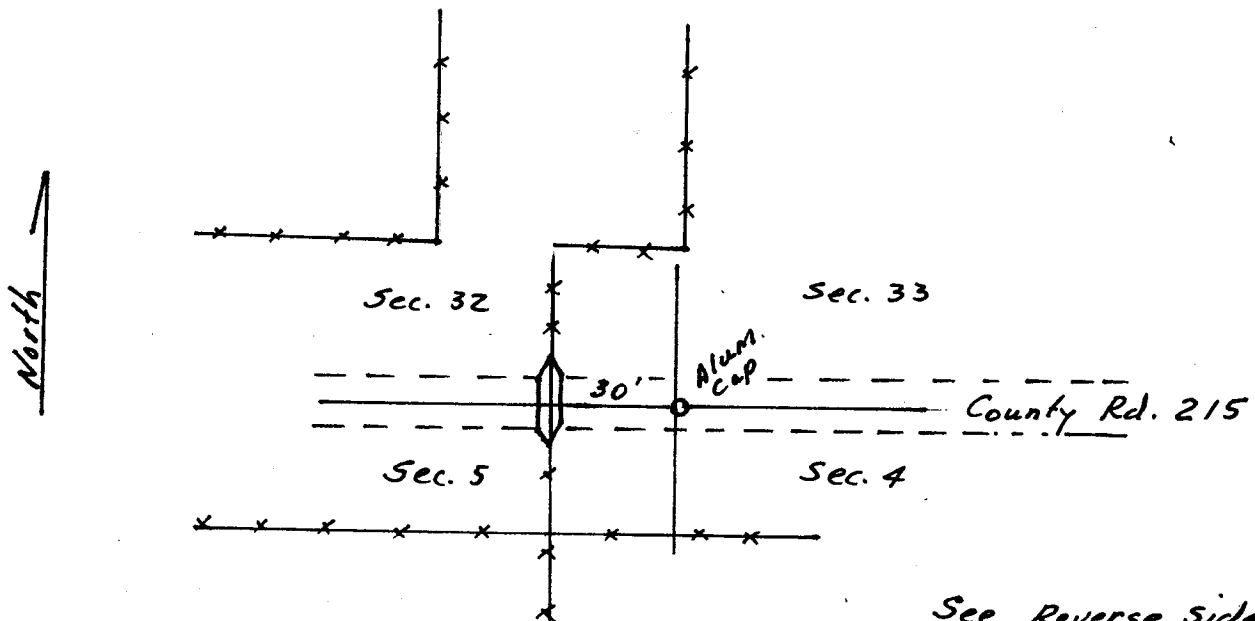
G.L.O. Monument assumed destroyed by County Road Construction which is described as a Granite Boulder 20" x 14" x 5".
