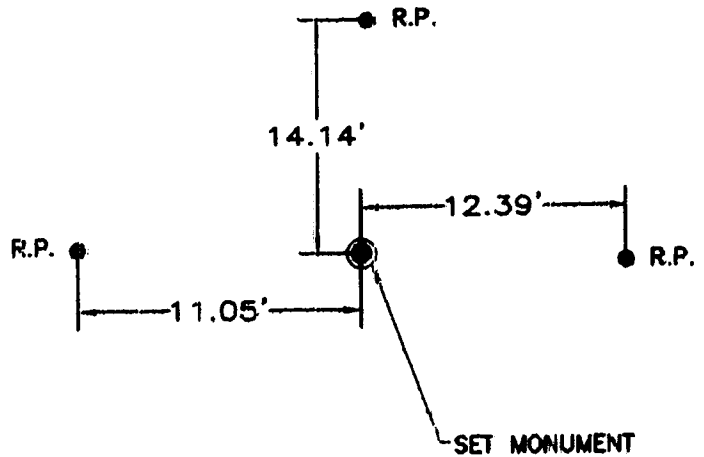

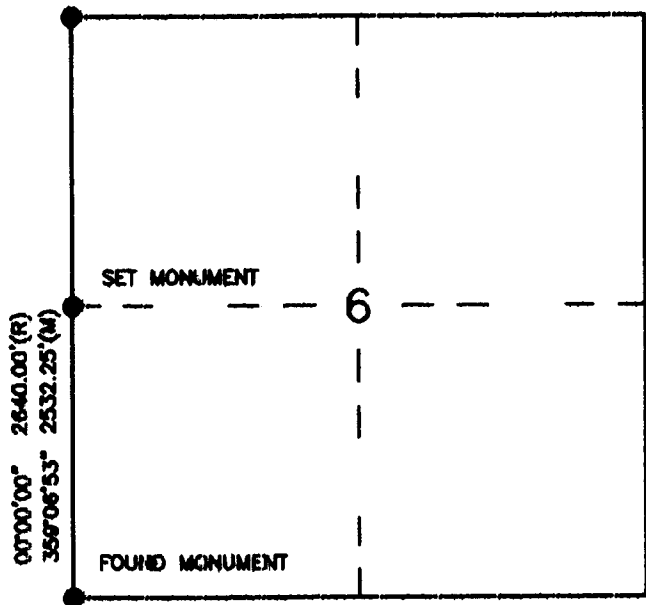

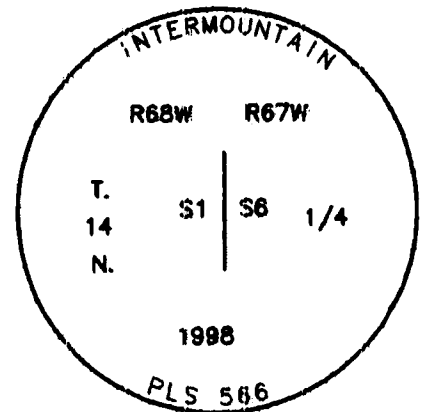
Monument Location

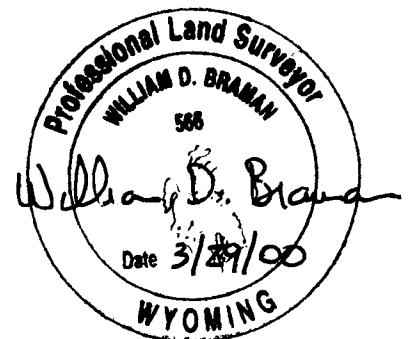
