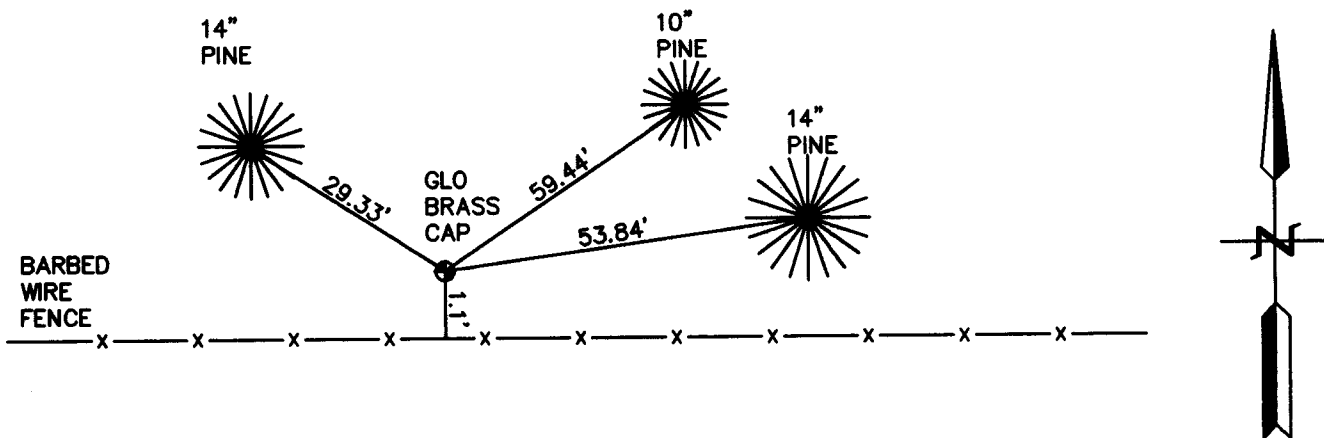

GLO RECORD: SET AN IRON POST, 3' LONG, 1" DIAMETER, 12" IN THE GROUND TO BEDROCK, AND IN A MOUND OF STONE TO TOP, WITH ORIGINAL STONE DEPOSITED ALONGSIDE. FOR THE 1/4 SECTION CORNER OF SECTIONS 2 AND 35, WITH BRASS CAP MARKED AS SHOWN BELOW.

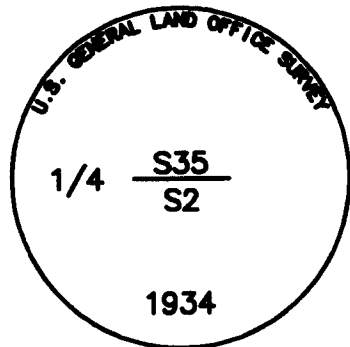
