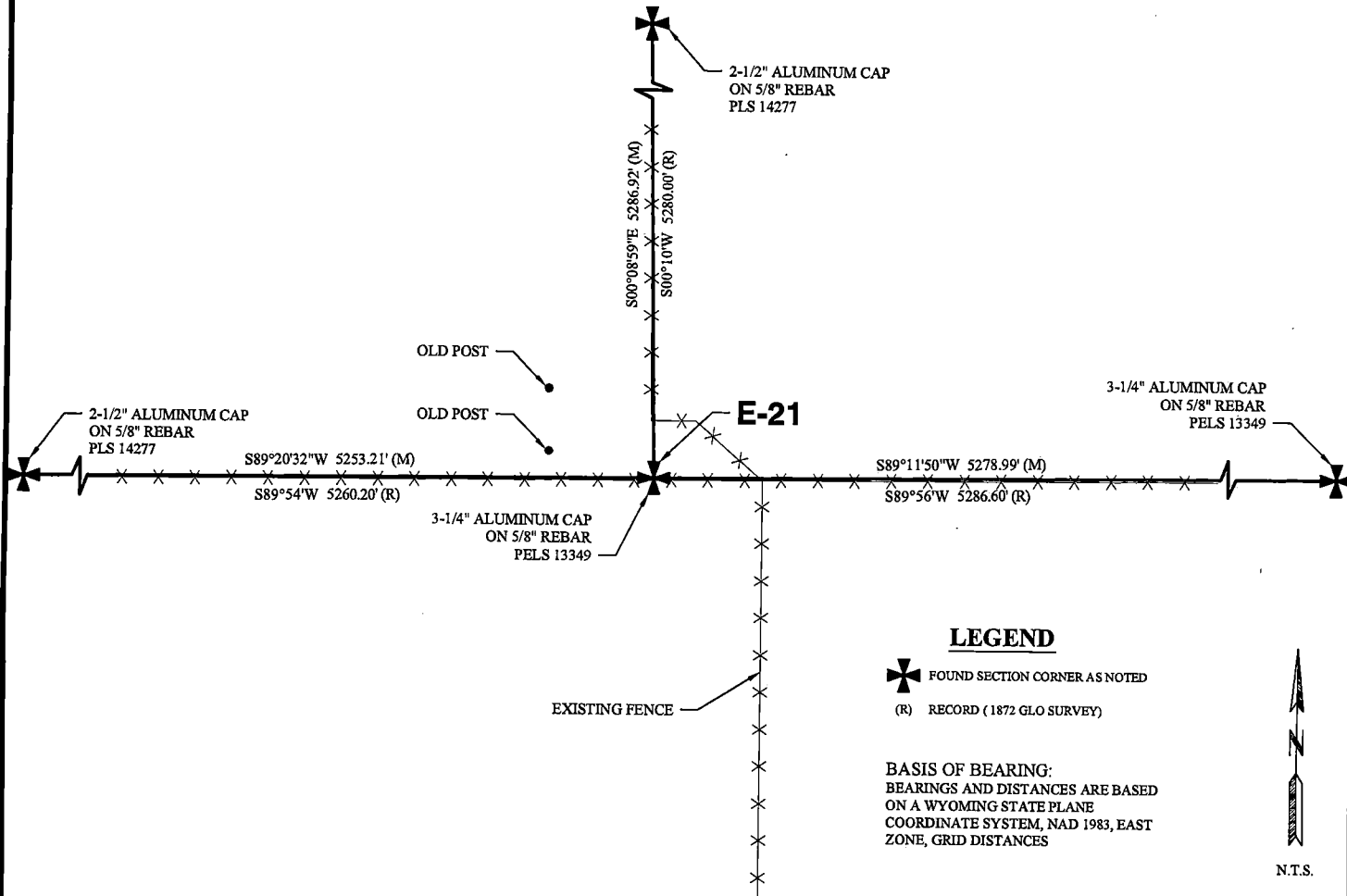
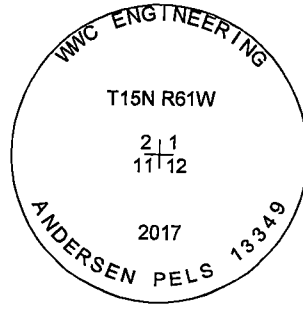

EVIDENCE RECORD: 1872 GLO Survey: North between sections 11 & 12, 80.00 chains. Set sand stone 20"x10"x4" for corner to sections 1, 2, 11 & 12.

EVIDENCE FOUND: September 2017: Sand stone from 1872 GLO survey not found. Two old posts and fence extending south suggests evidence of old fence right of way. Fence extending north in middle of old fence right of way. Accepted east-west fence and fence extending north as best available evidence for the corner to sections 1, 2, 11 & 12. Set a 3 1/4" aluminum cap marked as shown on a 5/8" rebar, 24" long, flush with ground.

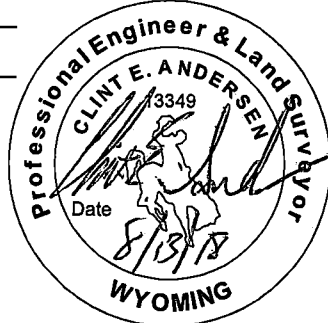
