



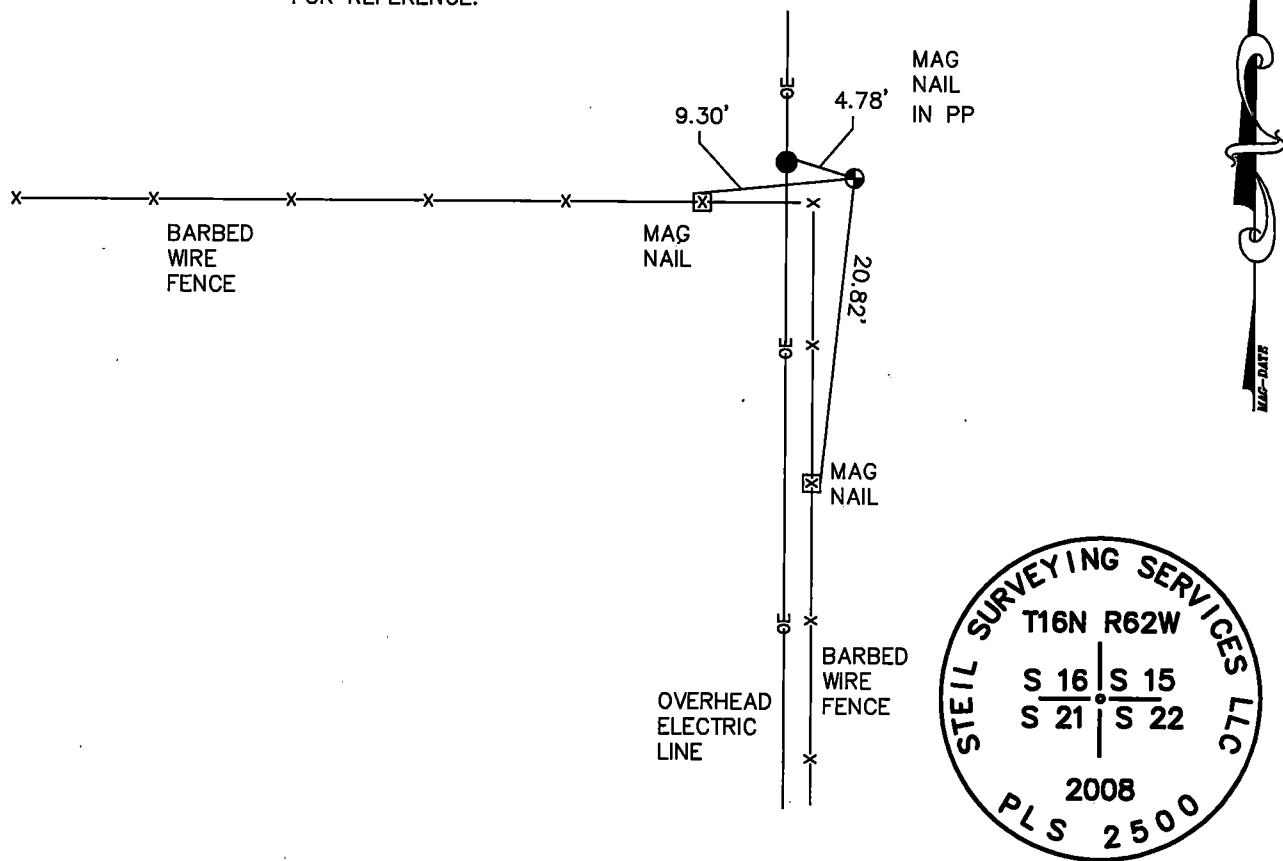
# State of Wyoming Corner Record

(In compliance with the CORNER PERPETUATION AND FILING ACT, Wyoming Statutes, 1997 Section 33-29-140 et. seq., and the Rules and Regulations of the Board of Professional Engineers and Professional Land Surveyors)

Description of corner monumentation evidence found and/or monument, and accessories established to perpetuate the location of this corner. - RECORD:** SET A SANDSTONE 22" X 12" X 3" FOR CORNER TO SECTIONS 15, 16, 21 AND 22.
- MONUMENT FOUND:** FOUND BROKEN PIECES OF SANDSTONE AT FENCE CORNER RUNNING WEST AND SOUTH.
- MONUMENT SET:** HELD FENCE CORNER AS BEST AVAILABLE EVIDENCE. SET A 5/8" X 24" REBAR WITH A 3 1/4" ALUMINUM CAP PROJECTING 0.4' ABOVE GROUND SURROUNDED BY MOUND OF STONE WITH THE CAP STAMPED AS SHOWN BELOW.
- REFERENCES:** MONUMENT LIES JUST NE OF FENCE CORNER. SET MAG NAILS FOR REFERENCE.
