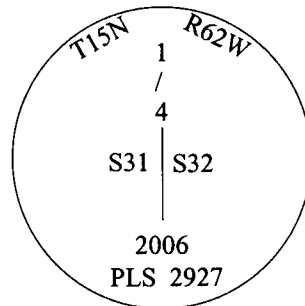

Subsequent Records: Laramie County Road Records, County Field Book No. 7, circa October 1, 1909, indicates the road was surveyed and notes "Set C.R. Stones, E & W. Good Road Stone o.k."

State of Wyoming Corner Record filed by me on 3/03/2003 indicating a found 2" diameter aluminum cap.

Set: The above found monument was removed during the construction phase of the Wyoming Department of Transportation Project No. 0C02-00(071) Burns North. Upon the completion of the mentioned project and at the request of the Wyoming Department of Transportation, I reset the above found monument with a No. 5 x 24" rebar and 3 1/4" diameter Brass Cap marked as noted below, 0.1' below the recently constructed asphalt roadway.

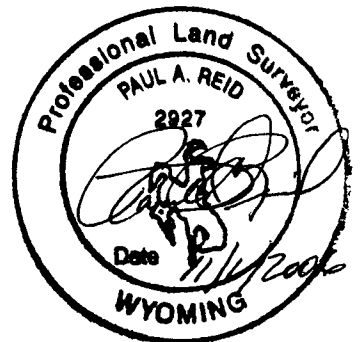
