



U.S.G.L.O. 1870 Record: Set a Limestone 18x10x5 for corner to sections 2, 3, 34 & 35.


Found 1-1/2" Aluminum Cap on a no. 5 rebar (no inscription) 0.5' below CR 215 gravel surface. Rehabilitate with a 2-1/2" Aluminum Cap on a 30" long no. 6 rebar. Set references and inscribed the rehab cap as shown below

Found 1-1/2" Al. Cap on a no. 5 rebar 0.5' below ground. Rehabilitate with a 2-1/2" Aluminum Cap on a 30" no. 6 rebar, inscribed as shown below.


