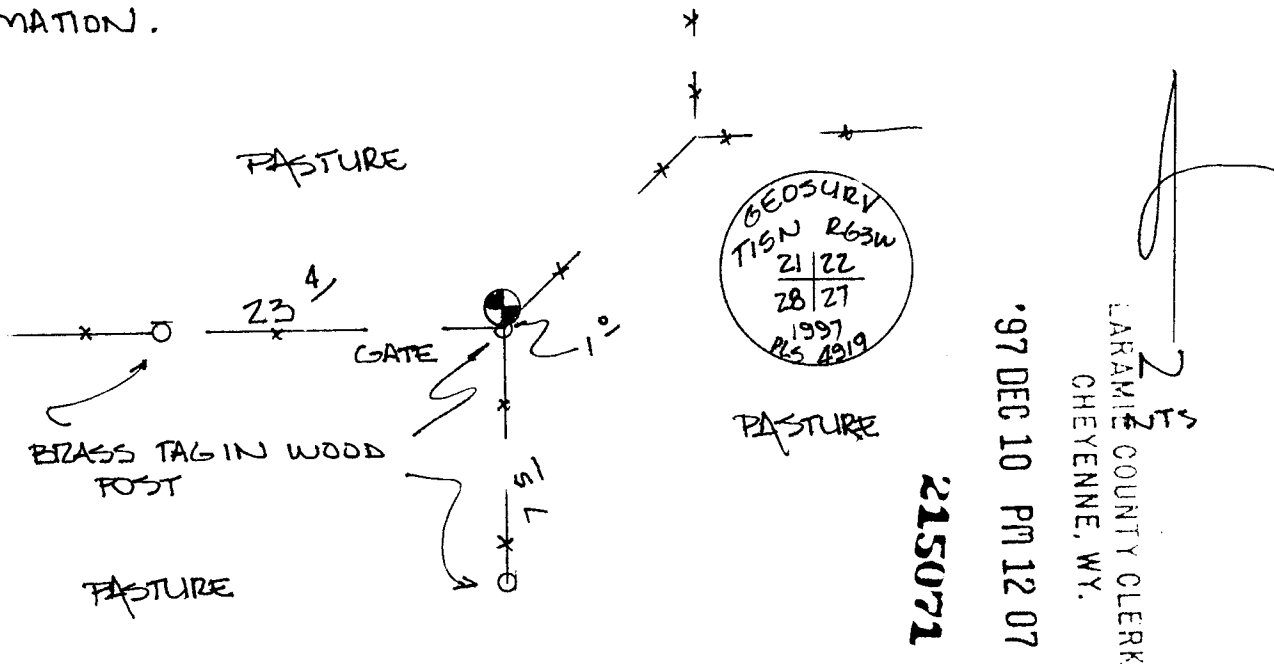

SANDSTONE 20' x 10" x 6"

MADE A THOROUGH SEARCH OF THE IMMEDIATE AREA OF THE EXISTING FENCE LINE INTERSECTIONS. FOUND NO TRACE OF THE CALLED FOR SANDSTONE. CONSIDER THIS CORNER TO BE OBLITERATED. CONSIDER THE FENCE LINE RUNNING SOUTH AND WEST TO BE THE BEST EVIDENCE FOR THE ORIGINAL POSITION OF THE CORNER COMMON TO  $\frac{21}{22}$  /  $\frac{28}{27}$ .

SET 2 1/2" Ø ALUM. CAP ON 30" LONG #6 REBAR AT FENCE LINE INTERSECTION. POSITION IS IN AGREEMENT WITH RECORD USGLO INFORMATION.
