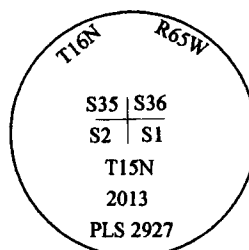
**Found:** Nothing

**Set:** At the proportionate distance along the township line, I set a no. 5 x 24 ins. rebar with 2 1/2 ins. diam. aluminum cap, marked as noted below, 8 ins. below the oil field service road surface. This corner is in the alinement of a old fence line latitudinally east.

This re-established corner is 12 ft. south of a 3 phase overhead powerline, 16.5 ft. east of the westerly north south row fence, 33 ft. west of a railroad tie fence corner post of fences extending east and south, 24 ft. north of a 18 ins. diam. cmp culvert and 8.5 ft. westerly of the center line of a oil field road constructed circa 1996.

The southeast corner of Section 36 bears S89°28'E, 5282.0 ft.  
The south 1/4 of Section 35 bears N89°28'W, 2641.0 ft.

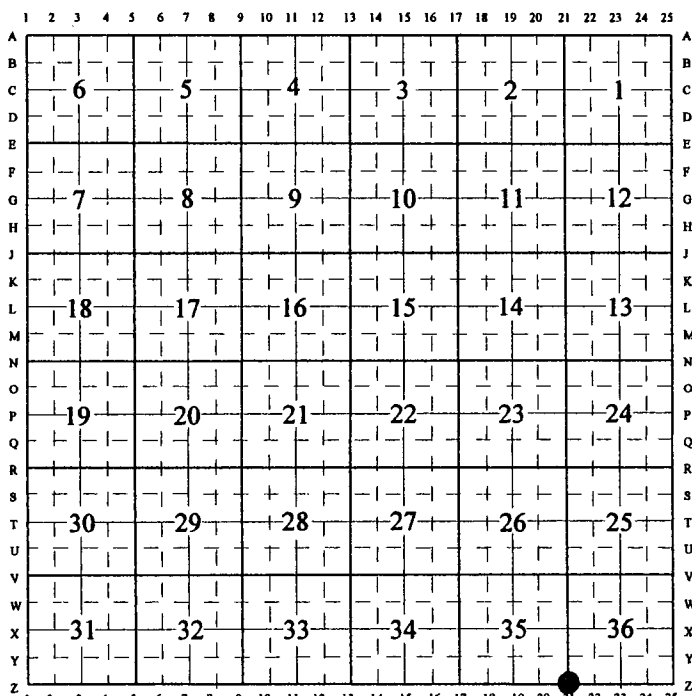
