

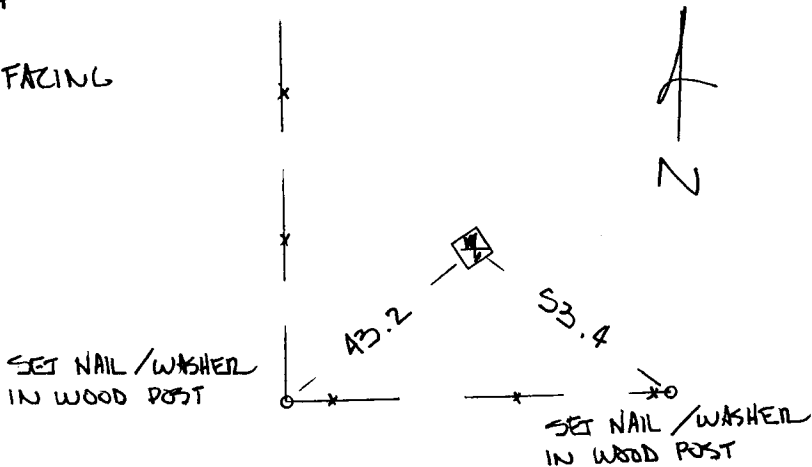

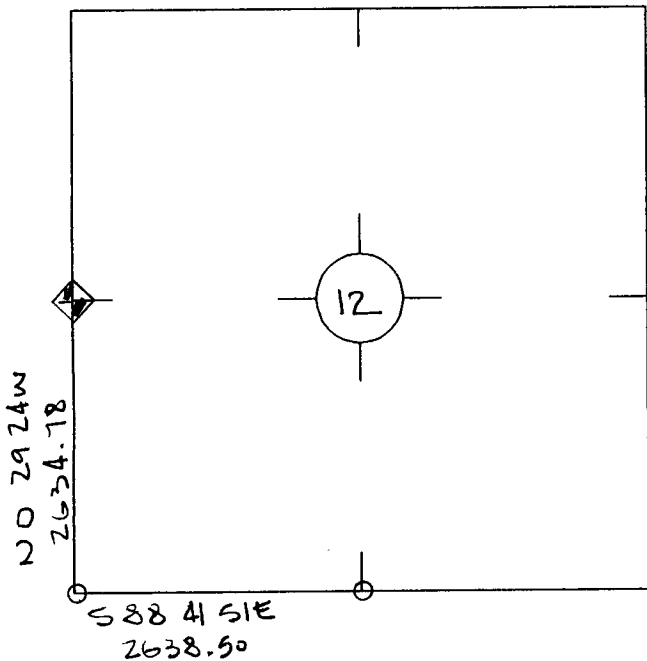

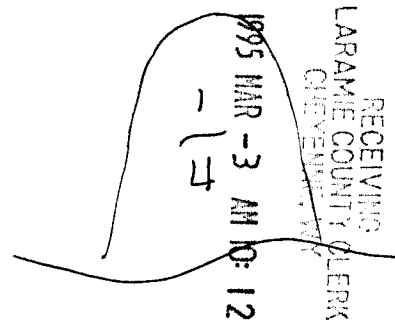
FOUND GRANITE STONE W/ $\frac{1}{4}$
