

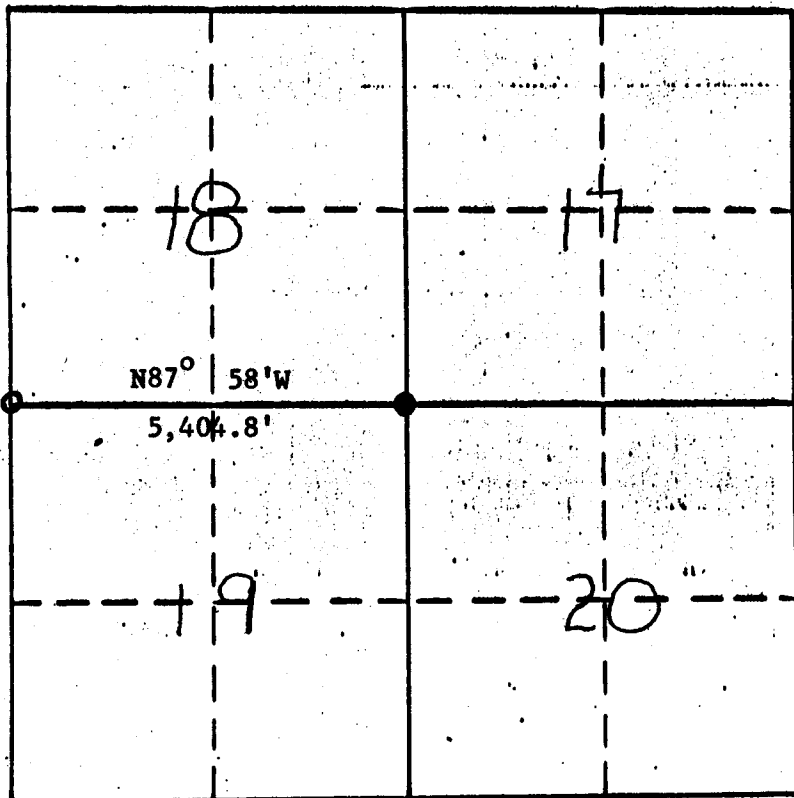
CERTIFIED LAND CORNER RECORDATION

DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (if known)

Found: near the N. E. Section Corner of Section 19, a witness corner which is a granite stone 7"x7" set solid & extending 5" above the ground with a cross chiseled on the top & W.C.-C.R. marked on the South side. Also, marked on the stone is N45° W56.56'. See details on back for further information.
