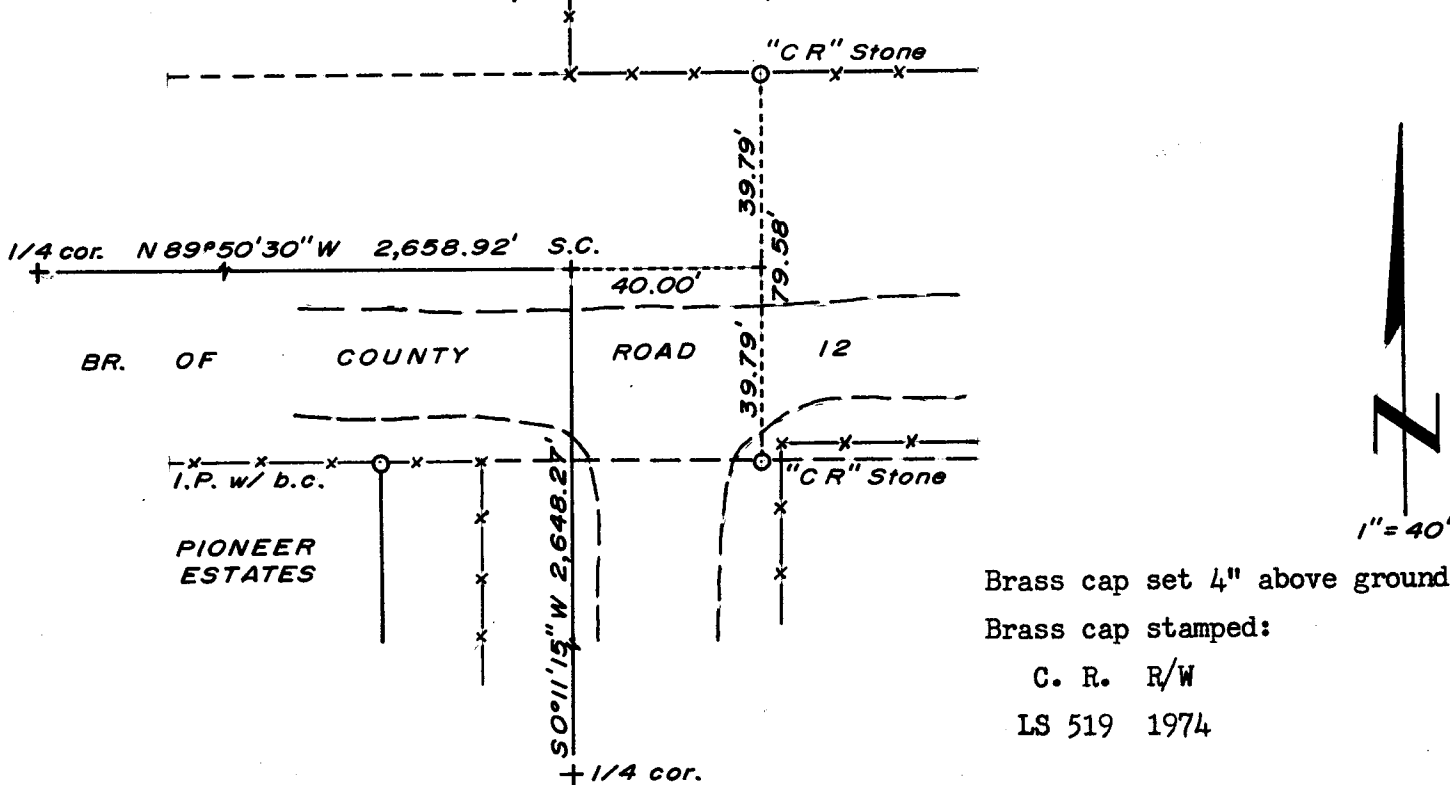

 56.58 feet distant.
