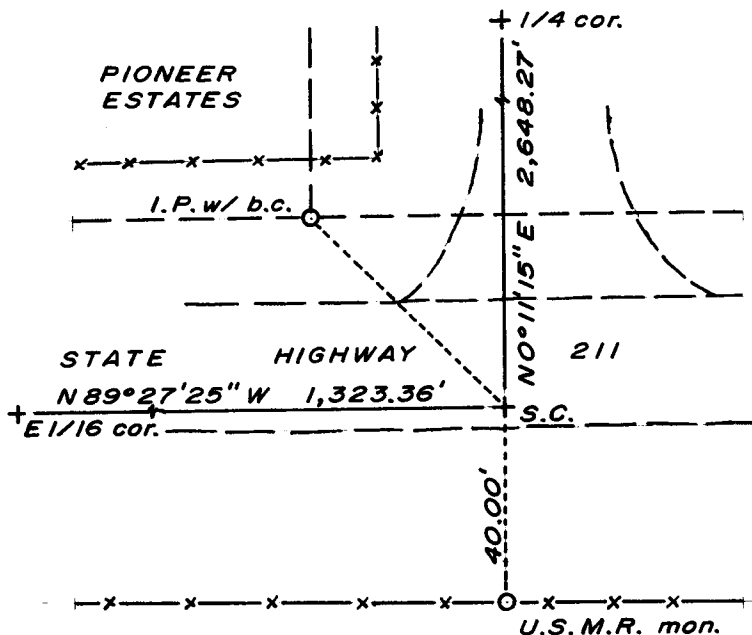

 A 1½" dia. x 30" long iron pipe with brass cap bears N 44°38'05" W, 56.74 feet distant. From this monument a 4" x 4" Redwood post with aluminum sign bears E'ly, 1 foot distant.
