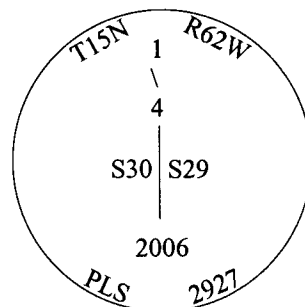

Set: The above found monument was removed during the construction phase of the Wyoming Department of Transportation Project No. 0C02-00(071) Burns North. Upon the completion of the mentioned project and at the request of the Wyoming Department of Transportation, I reset the above monument with a No. 5 x 24" rebar and 3 1/4" diameter Brass Cap marked as noted below, 0.1' below the recently constructed asphalt roadway.

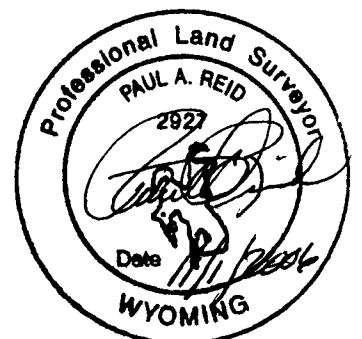
