

# State of Wyoming Corner Record

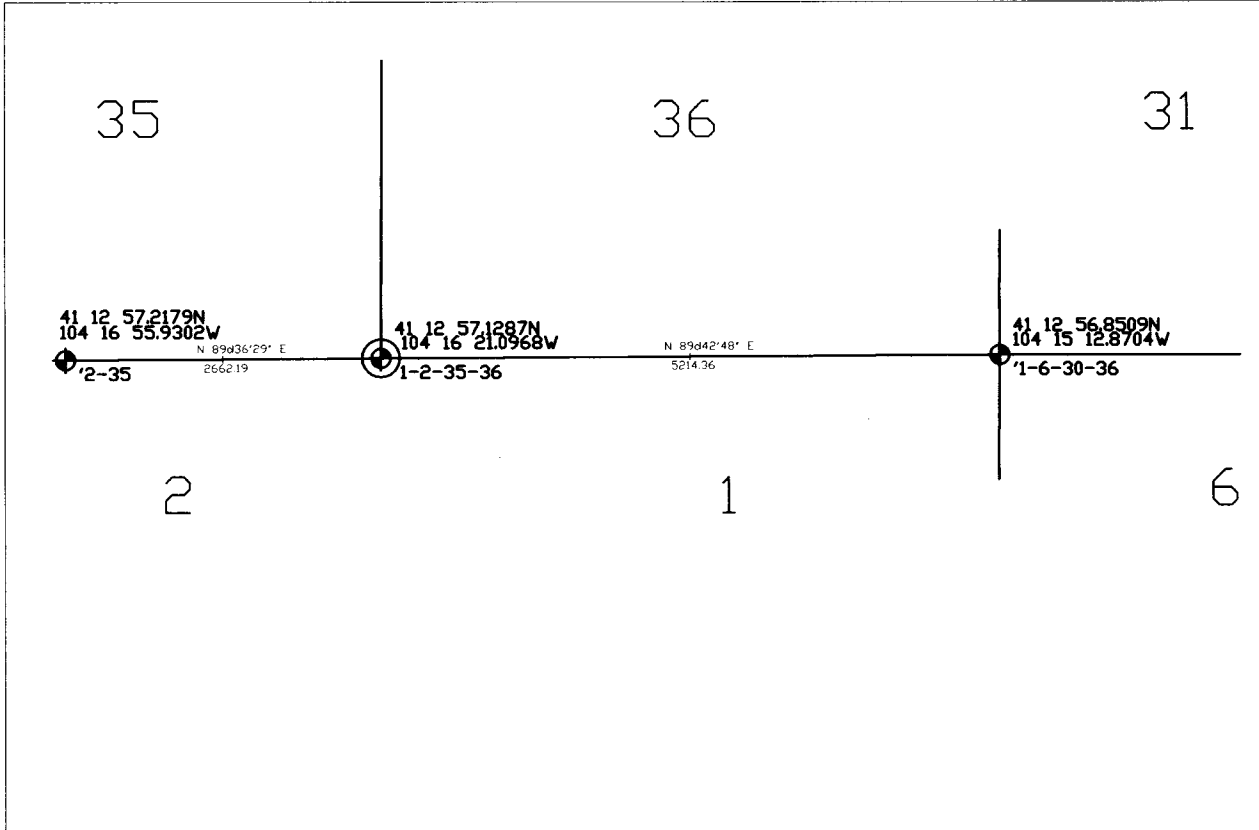

Description of corner monumentation evidence found and/or monument and accessories established to perpetuate the location of this corner. Sketch of relative location of monument, accessories, and reference points with course and distance to adjacent corner(s) (if determined in this survey). Method and rationale for re-establishment of lost or obliterated corner.

Found: Triangular shaped stone (18" on all sides by 6" thick) with faint marks on 6" edge . This stone was lying flat on the ground under an east-west fence. The distance tie from the township corner is 66 feet (one chain) short of that on the G. L. O. plat. Additional distances measured westerly along the township line from this point revealed stones and fence corners consistent with G. L. O. calls.

Set: 2.5" aluminum cap on a 5/8" by 24" rebar at base of fallen stone. Aluminum cap marked "SPURLOCK LAND SURVEYING, PLS 8279".

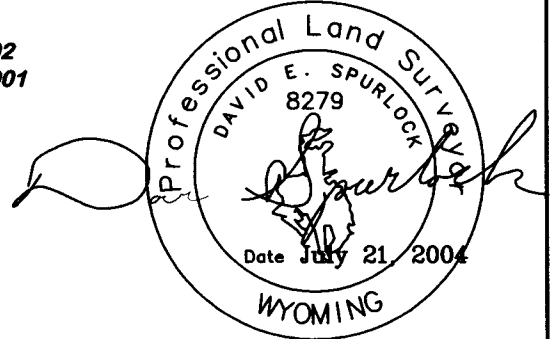
