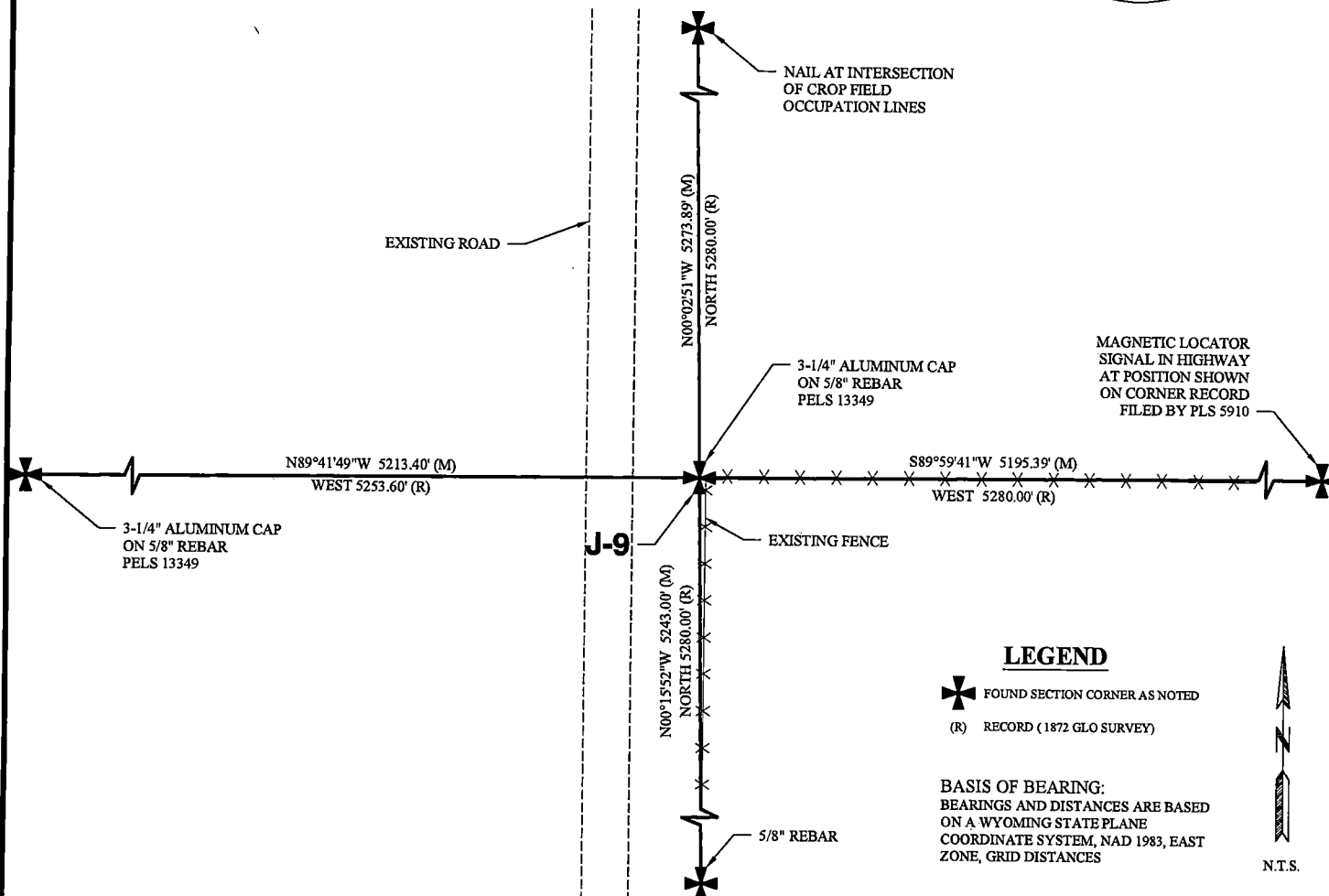
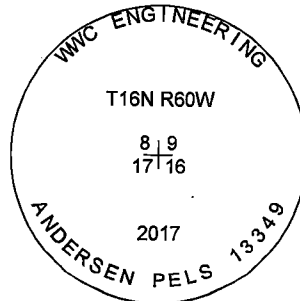

EVIDENCE RECORD: 1872 GLO Survey: North between sections 16 & 17, 80.00 chains. Set a sand stone 20"x12"x4" for corner to sections 8, 9, 16 & 17.

EVIDENCE FOUND: November 2017: Sand stone from 1872 GLO survey not found. Found nail and flagging at fence intersection extending south and east. Accepted as best available evidence for the corner to sections 8, 9, 16 & 17. Set a 3 1/4" aluminum cap marked as shown on a 5/8" rebar, 24" long, flush with ground surface and set nail alongside.

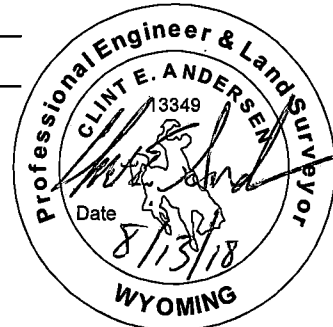
