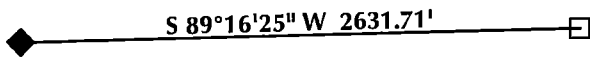

SET: Set 2 1/2" aluminum cap, stamped PLS 15626, beside set stone, projecting 6" above the surface, in North-South fence line, see detail below.

Monument Location

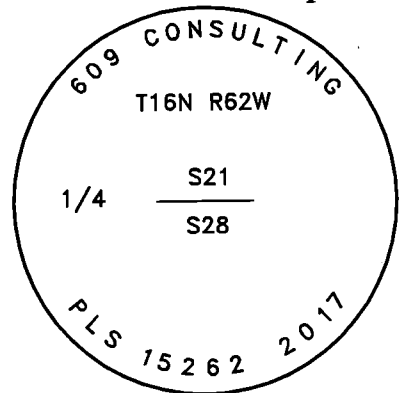
