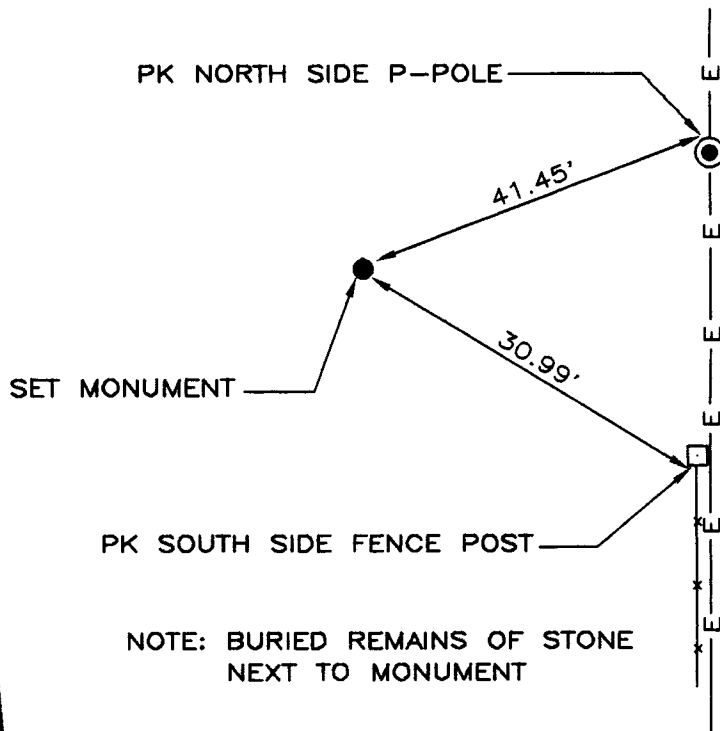

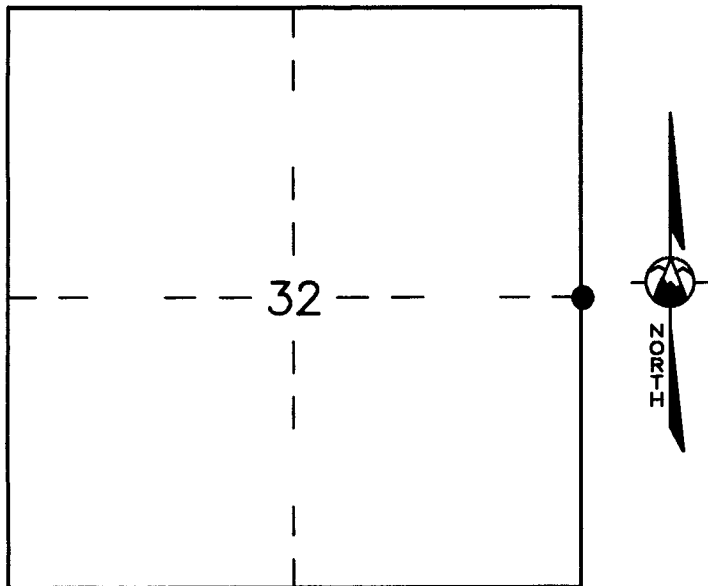

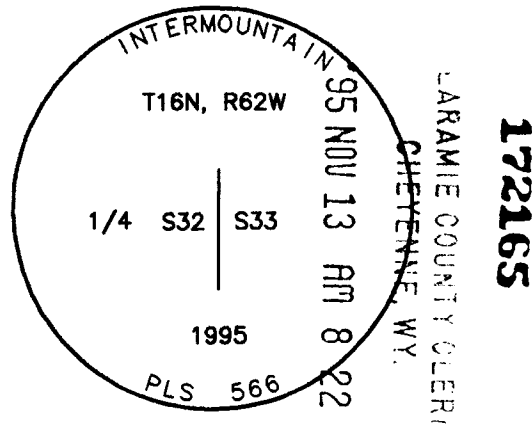
Reference Locations

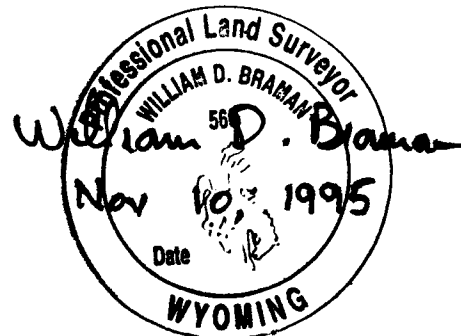
