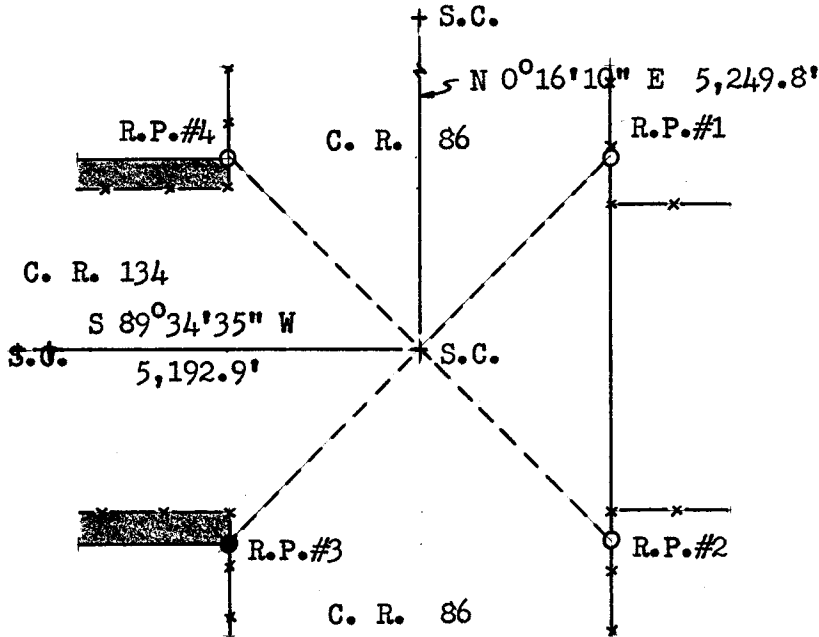

R.P.#2 - A 5/8" x 24" rebar w/ SurvKAP bears S 45°04'35" E, 56.23' distant.  
R.P.#3 - A 1 1/2" x 30" iron pipe w/ brass cap bears S 44°55'25" W, 56.91' distant. Set witness post, 1.5' west of R.P.#3.  
R.P.#4 - A 5/8" x 24" rebar w/ SurvKAP bears N 45°04'35" W, 56.23' distant.
