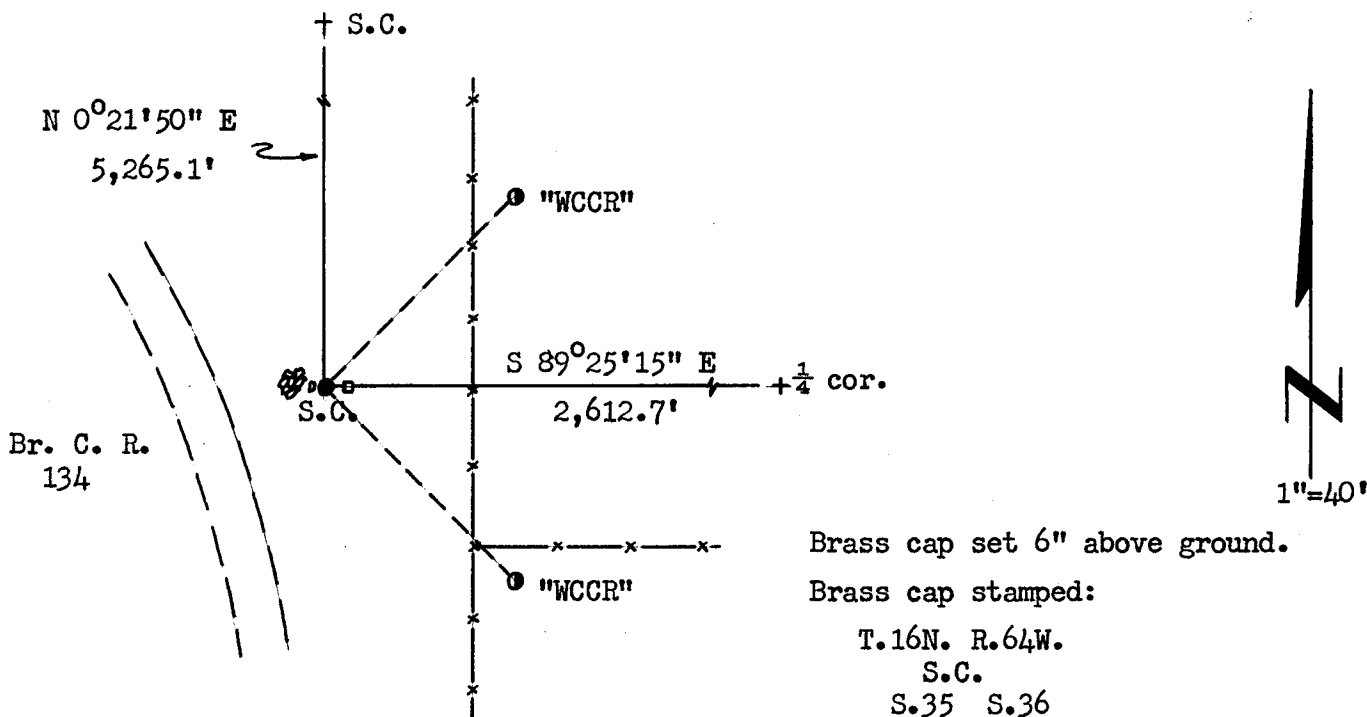

 G.L.O. record: Limestone, 20 x 12 x 8, John B. Thomas, 1871.

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set a 1½" dia. x 30" long iron pipe with brass cap.
 Accessories: Raised a rock mound, 3' west of corner monument.
 Set a 4" x 4" redwood witness post, 1.5' east of corner monument.
 Left stone as memorial.
