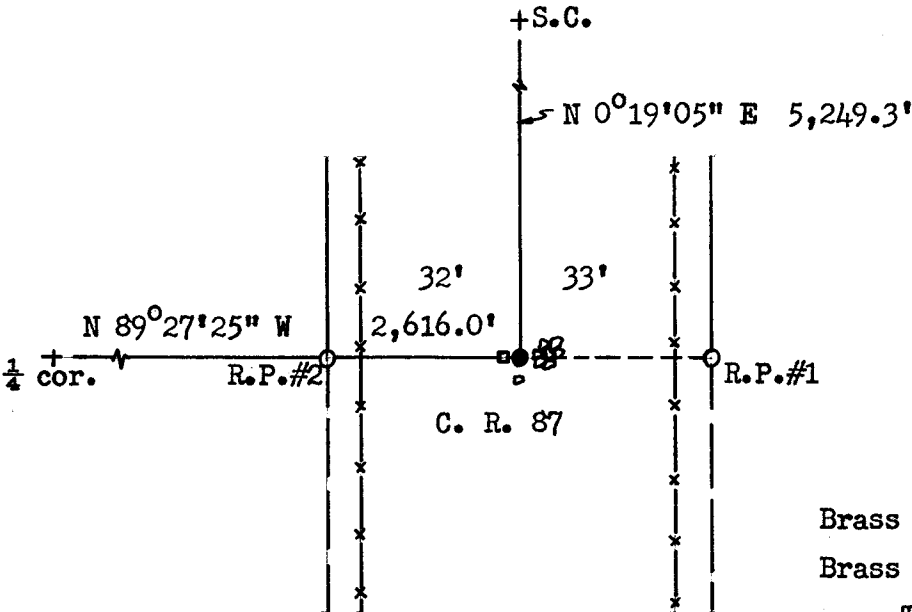
DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (If known)

LOCATION Found 6" x 12" x 20" sandstone, buried, with 6 grooves on each face.  
 T.16N. Stone buried (and referenced) by Laramie County Surveyor.  
 T.15N. G.L.O. record: Limestone 22 x 15 x 9, with rock mound, John B. Thomas, 1871.

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set a 1 1/2" dia. x 30" long iron pipe with brass cap.  
 Accessories: R.P.#1 - A 5/8" x 24" rebar w/ SurvKAP bears S 89°40'55" E, 40.00' distant.  
 R.P.#2 - A 5/8" x 24" rebar w/ SurvKAP bears N 89°40'55" W, 40.00' distant.  
 Raised a rock mound, 3' east of corner monument.  
 Set 4" x 4" redwood witness post, 1.5' west of corner monument.  
 Left stone as memorial.
