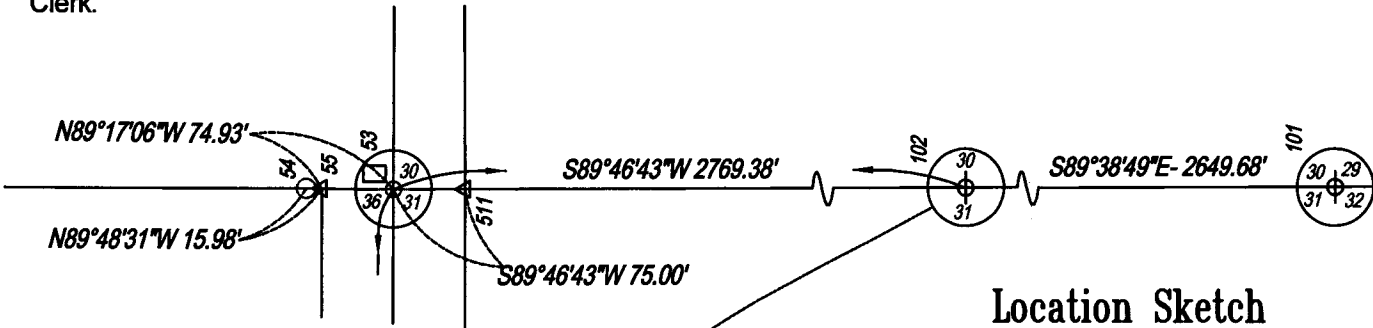

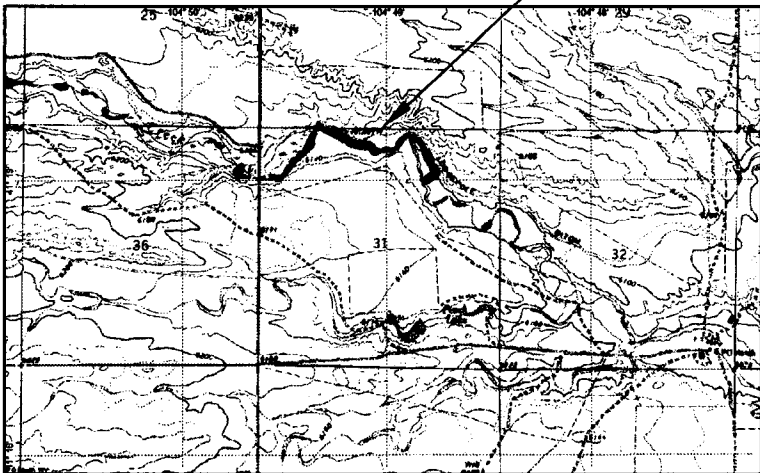
FOUND: Loose stone Grey Granite stone- no marks observed

SET: 3/4 in Aluminum cap on 3/4" x 30" Rebar inscribed as shown below in found mound of stone

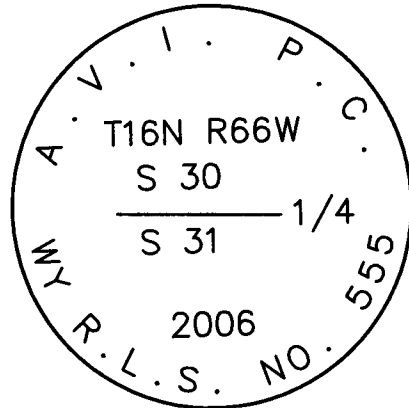

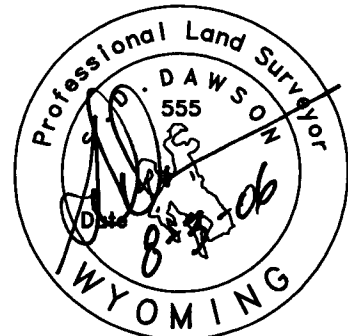
