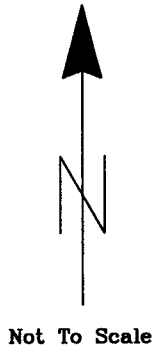

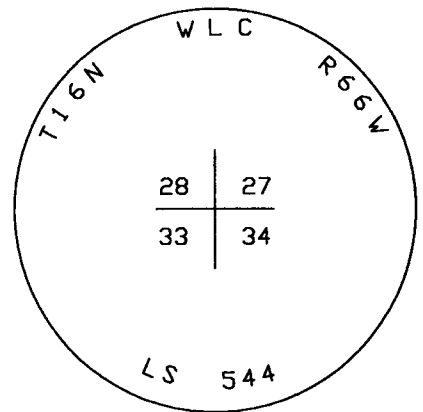

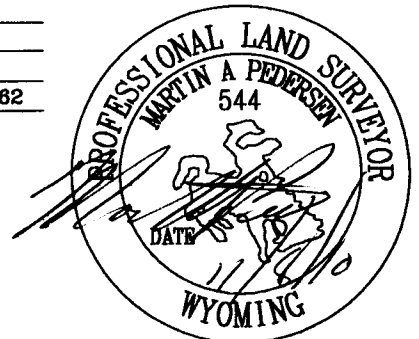
Cross Index Diagram
