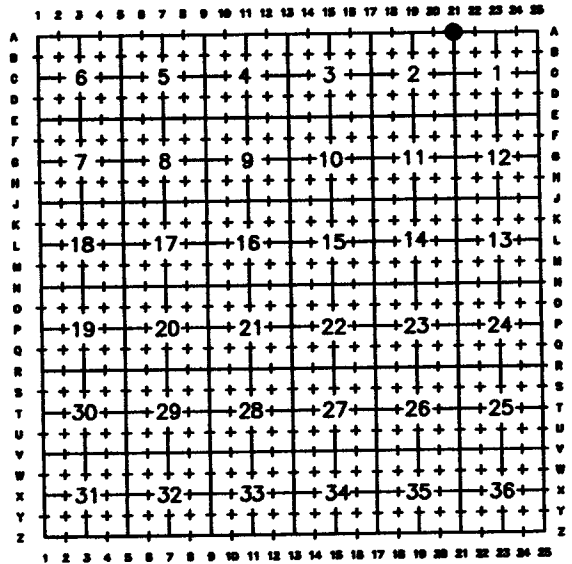

Cross Index Plat



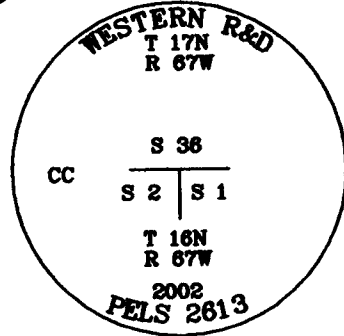
