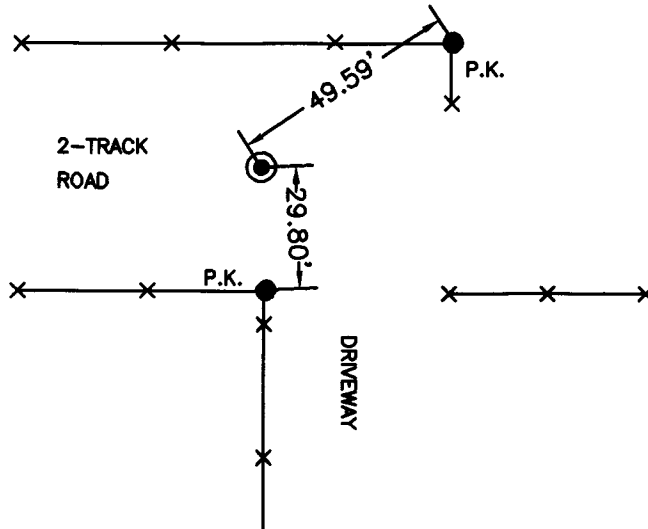

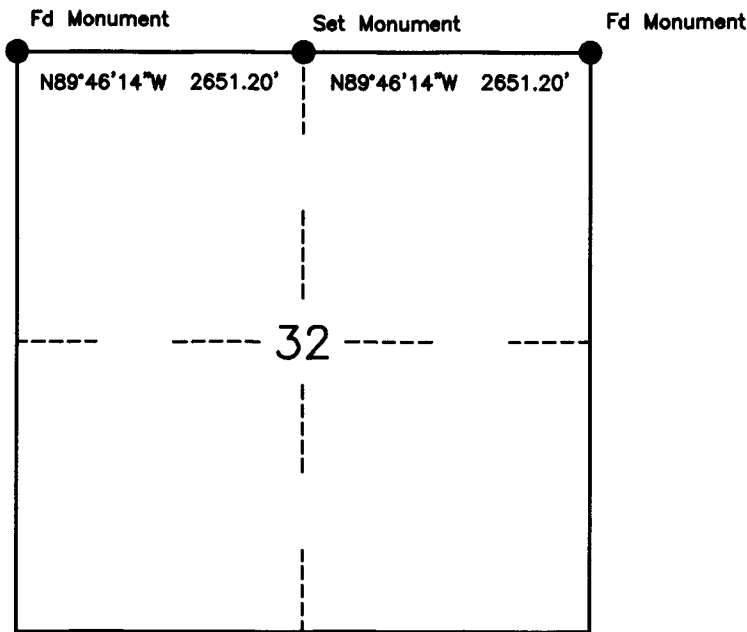

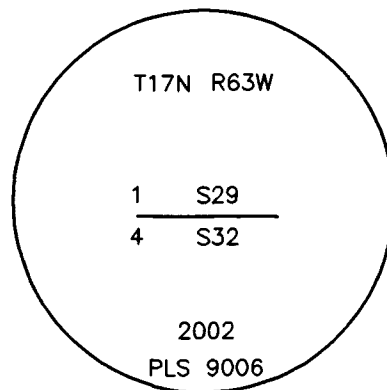
Reference Locations
