


**FOUND:** Found loose unmarked stone and accepted it's location as the best available evidence for the position of the corner.

**SET:** Set 2 1/2" aluminum cap, stamped PLS 12703, at the surface of the ground, on 24" #5 rebar at the position of the found stone. Laid stone alongside the monument.
