


FOUND: Nothing.

SET: Set 2 1/2" aluminum cap, stamped PLS 12703, at the surface of the ground, on 24" #5 rebar. Monument location set at extension of fence line running east to the stone at the southeast corner of Section 19 and on line between the W.1/4 corner of Section 18 to the north and the southwest corner of Section 30 to the south. Monument lies 9' west of fence corner with fence lines running north and east.
