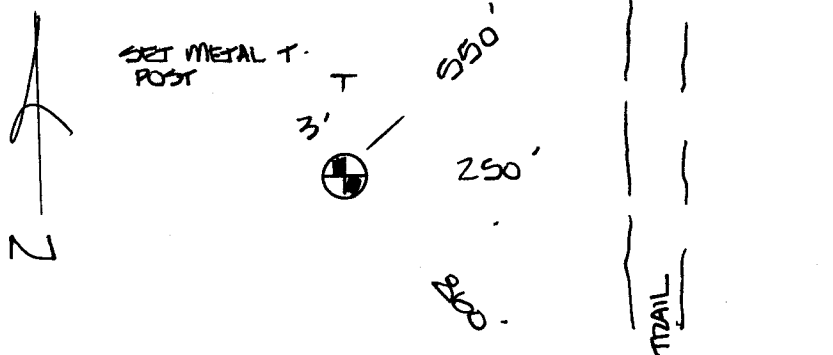

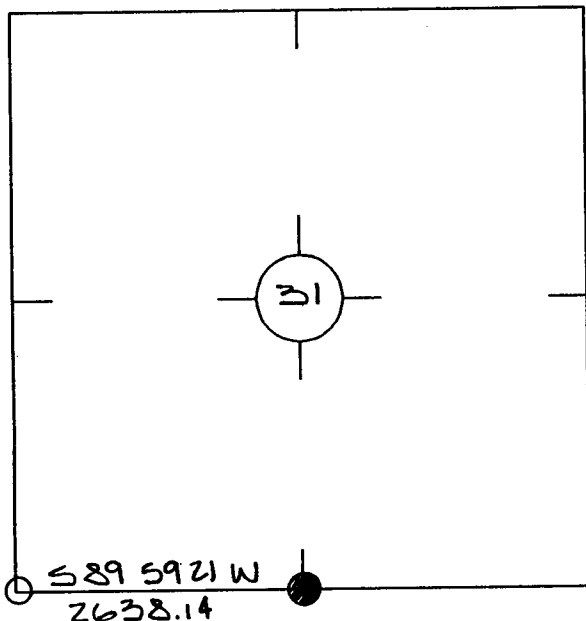

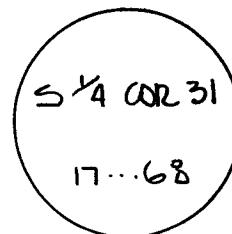


Monument location
