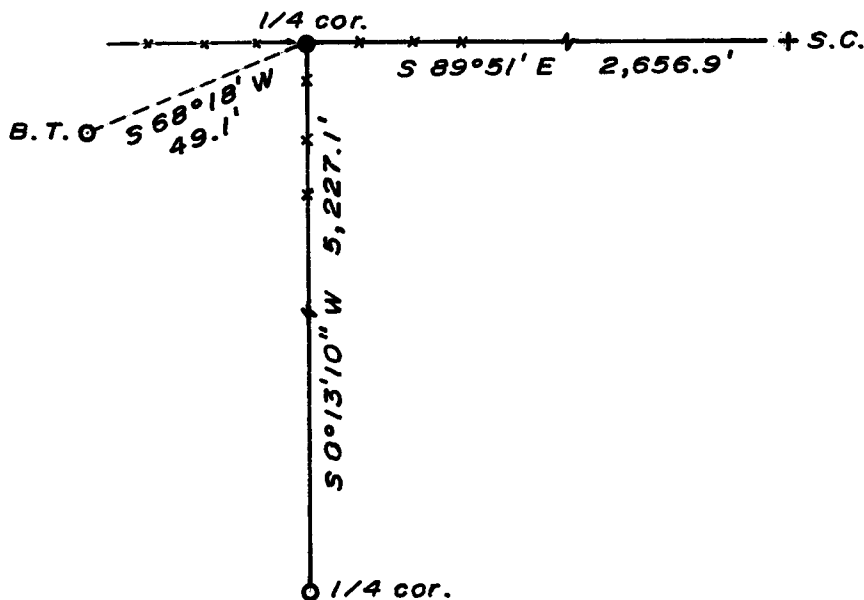

LOCATION Found G.L.O. stone lying against fence corner post and 30" dia. Pine snag with open blaze and scribing.

 6th P.M.  
 G.L.O. record - "Set a Granite Boulder 20 x 15 x 7 for  $\frac{1}{4}$  Sec. Cor. from which a Pine tree 20 inch dia Bears N.  $37^{\circ}$  W. 54 lks. dist. A Pine tree 30 inch dia. Bears S  $69^{\circ}$  W. 85 lks. dist." [John B. Thomas, 1872]  
 Corner re-established at fence corner.

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set a  $1\frac{1}{2}$ " dia. x 30" long iron pipe with brass cap.  
 Accessories: G.L.O. bearing tree bears S  $68^{\circ}18'$  W, 49.1 feet distant.  
 Note - Distances to bearing trees were found to be at considerable variance with G.L.O. record calls throughout this resurvey.
