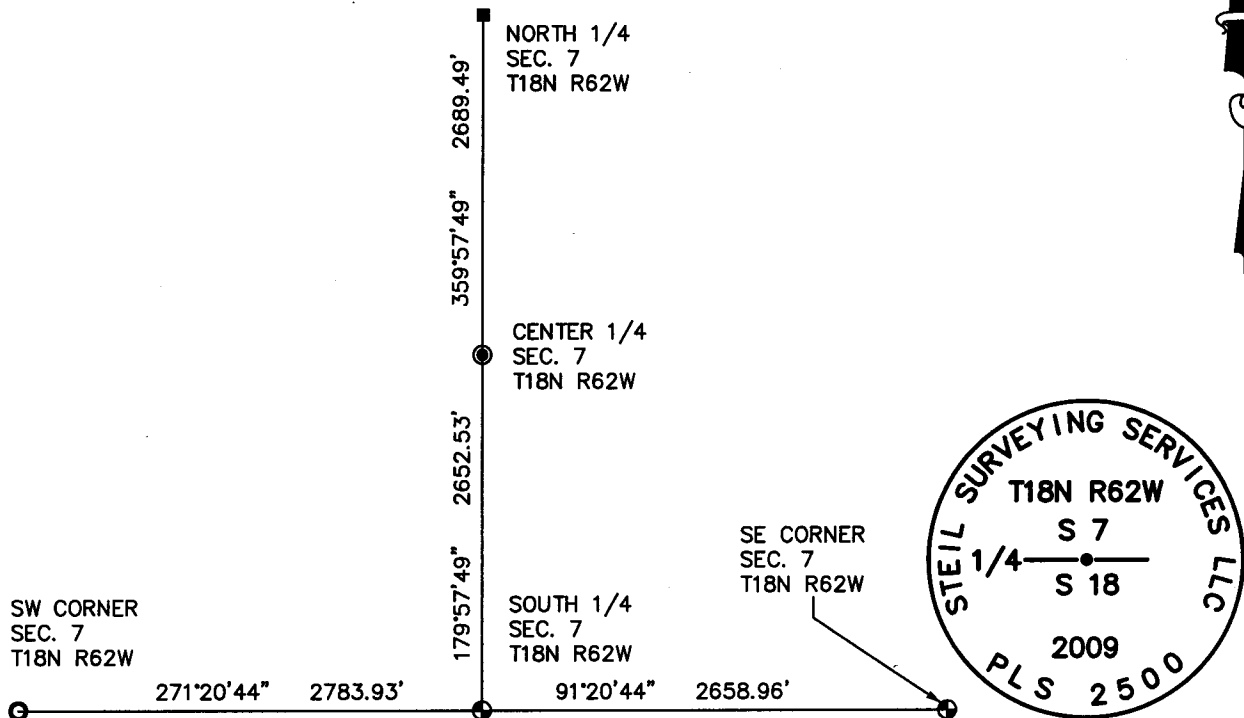

MONUMENT SET: SET A 5/8" X 24" REBAR WITH A 3 1/4" ALUMINUM CAP PROJECTING 0.4' ABOVE THE GROUND SURFACE WITH THE CAP AS SHOWN.

REFERENCES: MONUMENT LIES 7' NORTH OF A E-W BARBED WIRE FENCE AND 10' SOUTH OF A E-W TWO TRACK TRAIL ROAD. SET MAG NAILS FOR REFERENCE. MONUMENT WAS SET BY SINGLE PROPORTION.

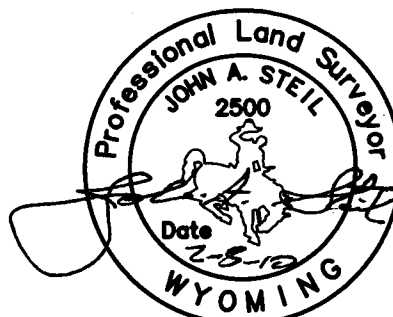
