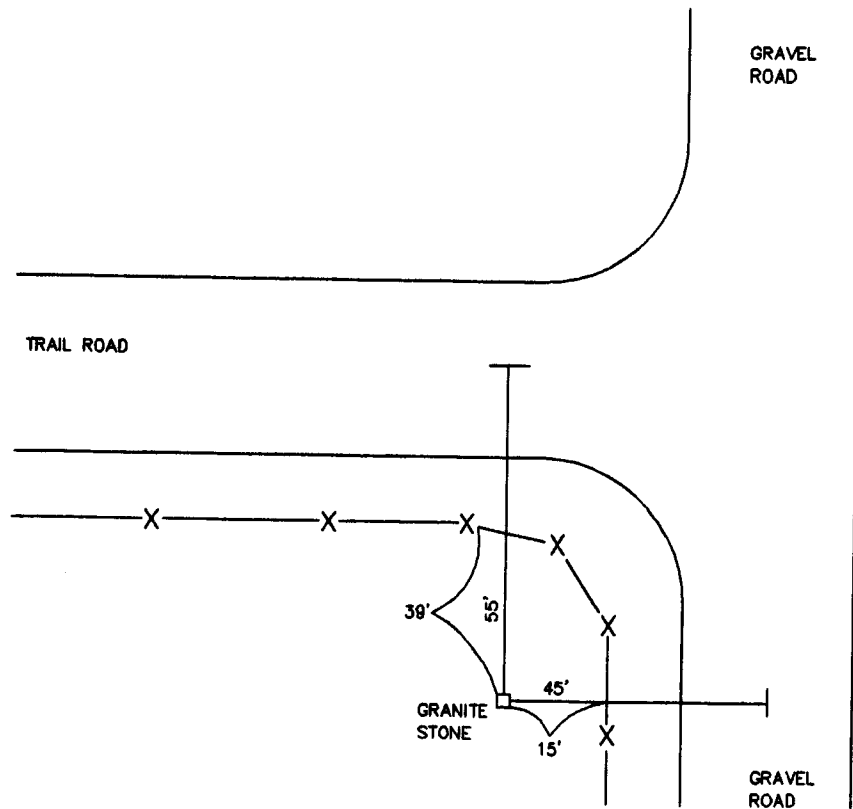

MONUMENT FOUND: FOUND A GRANITE STONE 10" X 10" PROJECTING 12" ABOVE THE GROUND WITH 4 NOTCHES ON THE EAST FACE AND 2 NOTCHES ON THE WEST FACE.

MONUMENT SET: NOTHING SET.

REFERENCES: MONUMENT LIES 15' WEST OF A NORTH - SOUTH BARBED WIRE FENCE AND 55' SOUTH OF A EAST - WEST TRAIL ROAD.
