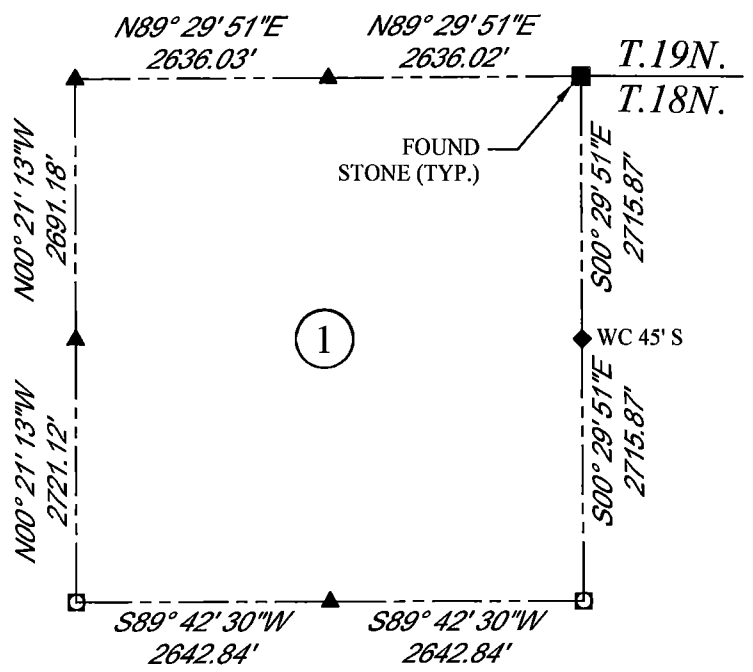
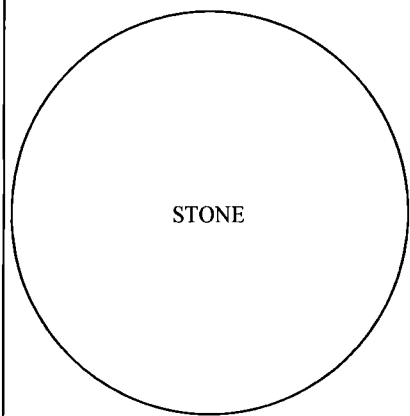
## NORTHEAST CORNER SECTION 1, T. 18 N., R. 63 W., 6TH P.M., LARAMIE COUNTY, WYOMING

GLO: SET A GRANITE STONE 22X10X8 WITH 6 MARKS ON EACH OF THE 4 FACES SET TO THE CARDINAL POINTS. SET 15 IN. DEEP AND RAISED A MOUND OF STONES AROUND IT FOR CORNER TO TOWNSHIPS 18 AND 19 NORTH. RANGES 62 AND 63 WEST.

FOUND: FIRM SET GRANITE STONE WITH MARKINGS ON 1 FACE. ORANGE SURVEY MARKER IN FENCE LINE BY STONE.
