



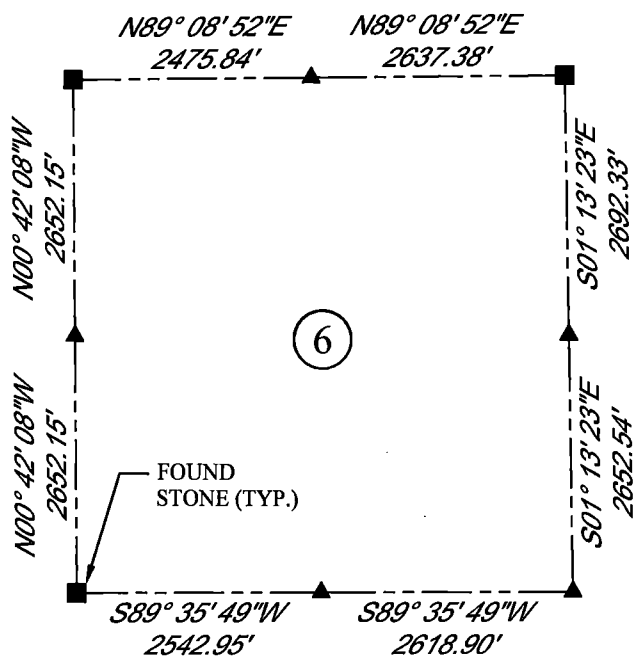
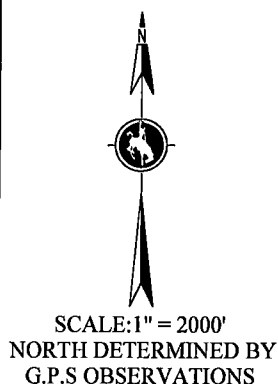

GLO: SET A GRANITE STONE 20X12X8, 15 IN. DEEP WITH 5 MARKS ON THE SOUTH AND ONE ON THE NORTH EDGE FOR CORNER TO SECTIONS 1, 6, 7, AND 12.

FOUND: FOUND FIRM SET STONE (PINK GRANITE) APPROX. 19X9X8 0.3' ABOVE SURFACE, 17' EAST OF N&E FENCE CORNER, +/- 42' N. OF COUNTY ROAD. STONE IS DIRECTLY IN EAST FENCE LINE. 5 HASH MARKS CLEARLY EVIDENT ON S. FACE.
