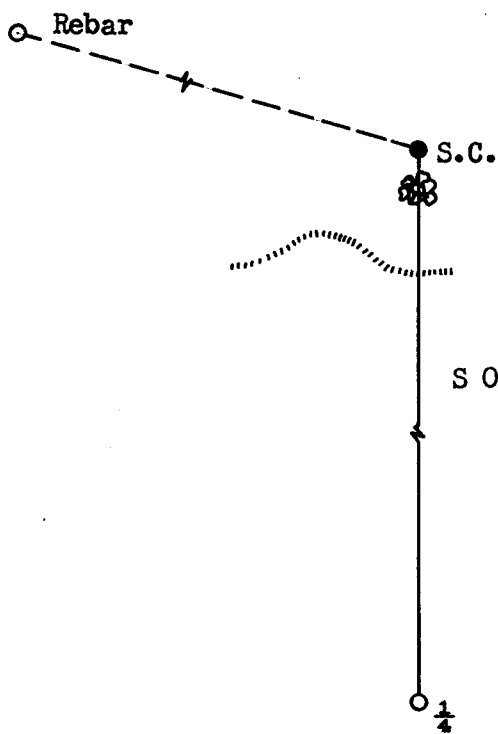
At the corner: Set a 1½" dia. x 30" long iron pipe with brass cap.

Accessories: A ½" dia. rebar (found) bears N 74°15' W, 106.2 feet distant.

Raised a rock mound, 3 feet south of corner.

Left stone as memorial.
