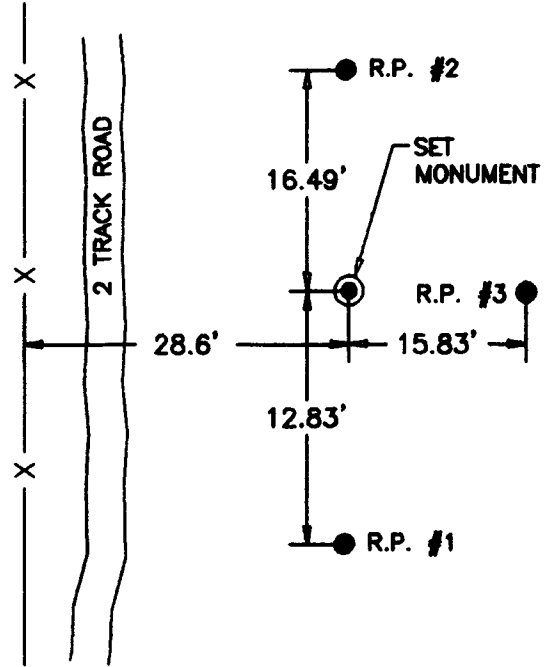

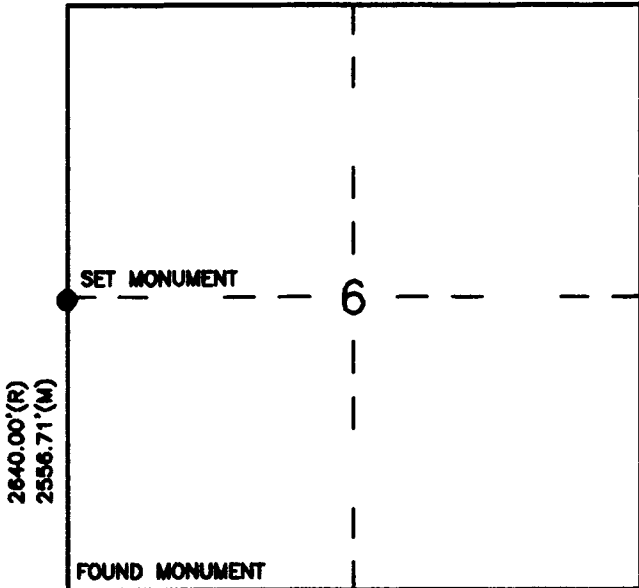

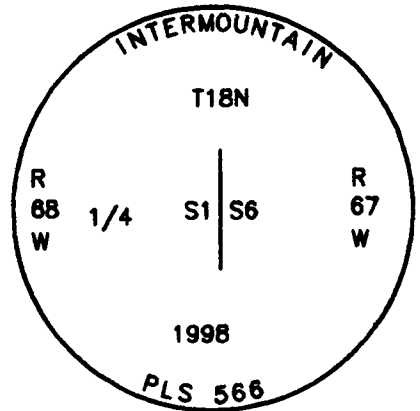


Monument Location
