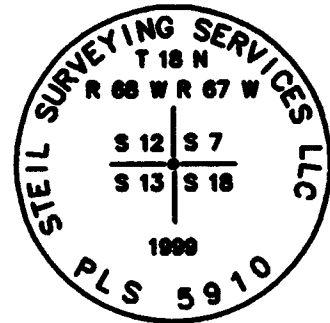
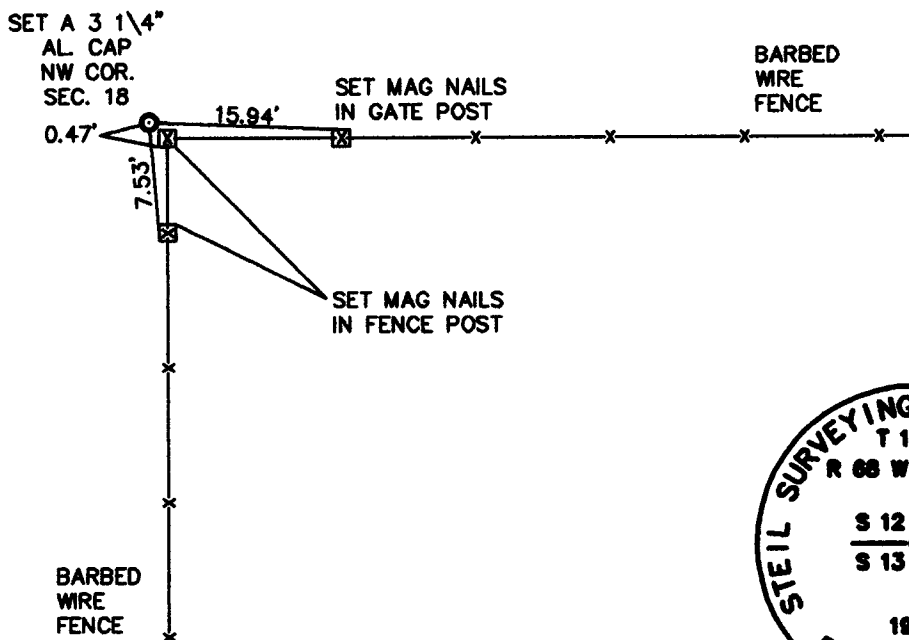

REFERENCES: MONUMENT LIES AT THE NW CORNER OF A FENCE CORNER RUNNING SOUTH AND EAST. SET MAG NAILS FOR REFERENCE. REFERENCES ARE SHOWN BELOW.

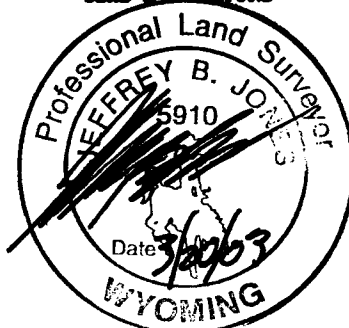
