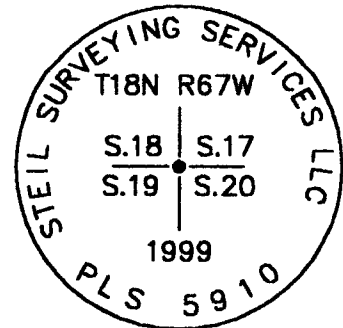
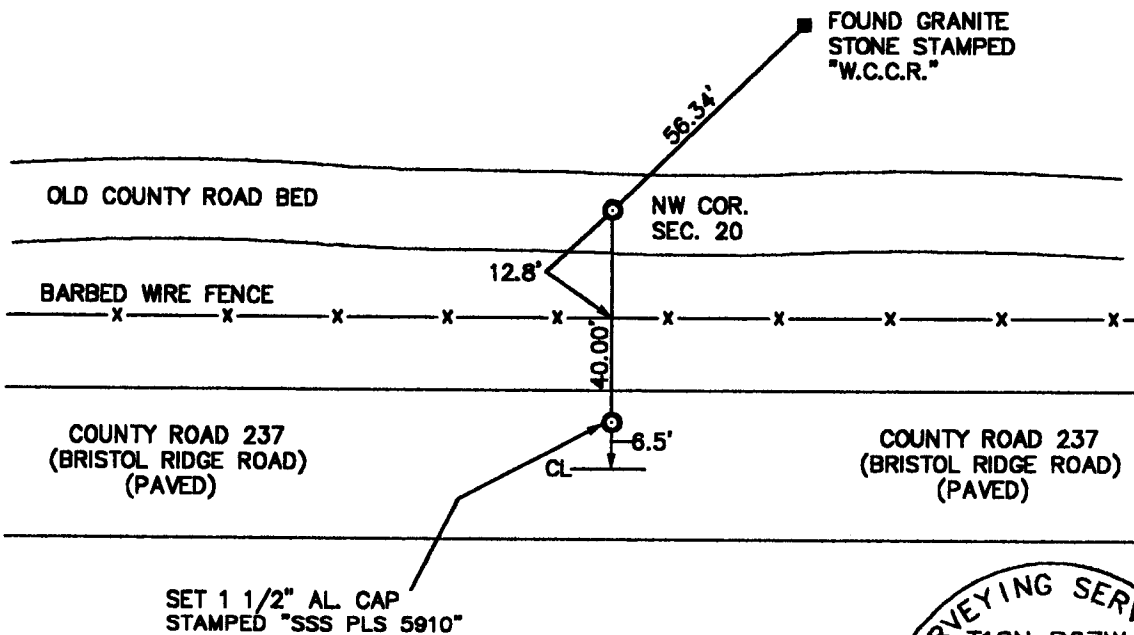

MONUMENT SET: SET A 5/8" X 24" REBAR WITH A 3 1/4" ALUMINUM CAP FLUSH WITH THE GROUND SURROUNDED BY A MOUND OF STONE. CAP IS STAMPED AS SHOWN BELOW.

REFERENCES: MONUMENT LIES 12.8' NORTH OF A E-W BARBED WIRE FENCE, AND IN THE BED OF THE OLD COUNTY ROAD ROUTE. REFERENCES ARE SHOWN BELOW.

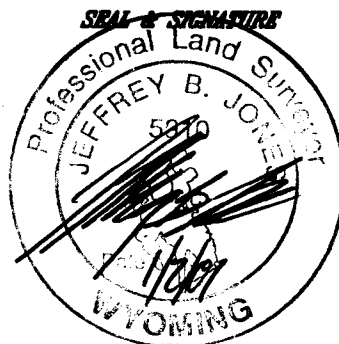
