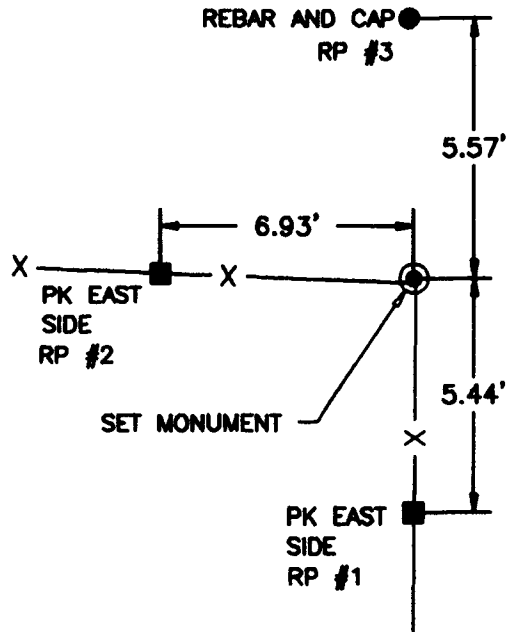

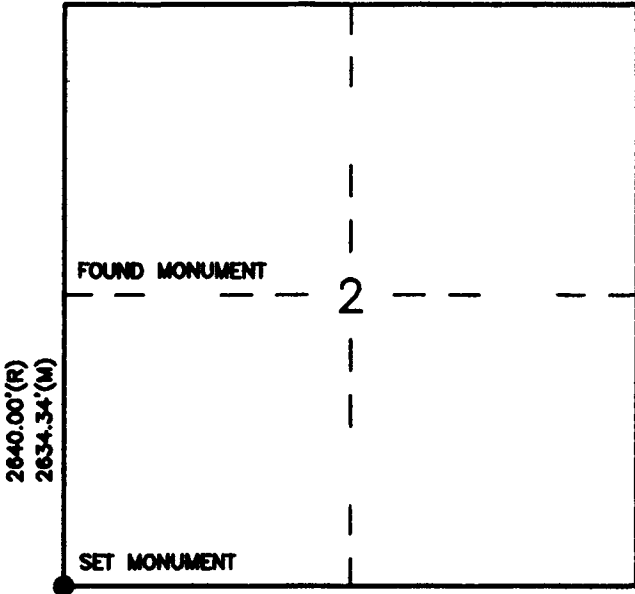

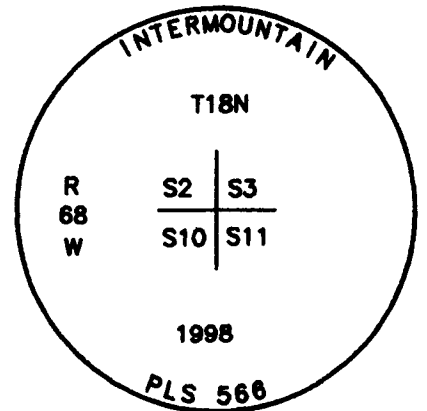


NOTE: BURIED STONE NEXT TO MONUMENT AS MEMORIAL

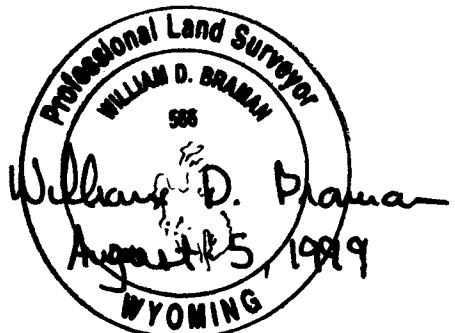
